

## **Vermont's Non-filers and Statistics on Renters**

## Who are the Vermonters who don't file income taxes?

- Vermonters are required to file a state income tax return if they are required to file federally and earned or received more than \$100 of Vermont income. <u>32 V.S.A. § 5861</u> (legislature.vermont.gov)
- People are required to file federally if their "gross income" is over the federal standard deduction amounts, which are: \$12,950 for Single, \$19,400 for Head of Household, and \$25,900 for Married (plus the additional \$1,400 standard deduction for being 65+ or blind, if applicable)
- Importantly, the federal filing requirement thresholds are a little higher for people receiving social security because some of it may be nontaxable. For people on social security, the thresholds are \$25,000 if the person is single or \$32,000 if married. For these filers, gross income is calculated differently: 50% of all social security benefits plus any tax-exempt interest plus all other gross income.
- This means that a not insignificant share of Vermont's population is not required to file a Vermont income tax return. In 2018, the Tax Department estimated the Vermont non-filer population at between 12% and 16%, or around 70,000 adults; the majority of whom are *legitimate* non-filers.

## Do any of them pay property taxes? If so, how many?

- Yes, in 2020 there were about 8,000 homesteads where neither the filer nor the spouse filed an income tax return
- Also, the Census reported about 13,000 more owner-occupied homes in 2020 than the department's total for declared homesteads. These could be households paying the nonhomestead property tax rate and they may or may not pay income taxes.
- That means that there are probably between 10,000 and 20,000 resident households that pay property taxes but not income taxes.
