Senator Kitchel moved that the Special Committee authorize the Joint Fiscal Office to negotiate and sign a contract with Gail Hutchings, President and CEO of Behavioral Health Policy Collaborative, in order to meet the requirements as set forth in Sec. 33(e) of H.630 of 2012. Senator Ayer seconded the motion, and the committee unanimously approved it.

H.630 calls for a Special Committee consisting of the Joint Fiscal Committee and the chairs and vice chairs of Senate Health and Welfare and House Human Services to hire a consultant. The consultant will evaluate the structure, services and financial implications of Vermont's proposed mental health system. The bill's language is attached.

I am proposing that this contract be negotiated with Gail Hutchings. Over the past several months I have spoken with five potential candidates to do this work. After discussions with all of them, I recommend the joint fiscal committee hire Ms. Hutchings. She is eminently qualified, and proposes a team of co-workers that can address the broad range of issues. Furthermore, over the past few months she has engaged in a few conversations regarding Vermont's mental health system and issues to consider and has done so free of charge. The cost is projected to be \$60,000-\$68,000 which is under the \$75,000 threshold for which formal bids would be solicited.

Also attached is a brief bio for Ms. Hutchings and a proposed statement of work.

Proposed Motion: The Special Committee authorizes the Joint Fiscal Office to negotiate and sign a contract with Gail Hutchings, President and CEO of Behavioral Health Policy Collaborative in order to meet the requirements as set forth in Sec, 33(e) of H.630 of 2012.

#### H.630 – Reforming Vermont's Mental Health System

- Sec 33 (e) A special committee consisting of the members of the joint fiscal committee and the chairs and vice chairs of the senate committee on health and welfare and the house committee on human services, in consultation with the commissioner of mental health shall contract with an independent consultant who has expertise in the field of mental health and psychiatric hospital services to evaluate the structure, services, and financial implications of Vermont's proposed mental health system. - (1) Whether Vermont's proposed mental health system appropriately serves the needs of individuals with mental health conditions throughout the state and, if any unmet needs are identified, how they may be addressed;
- (2) The data and evaluation mechanisms necessary to manage and improve the quality of care and outcomes for individuals in Vermont with a mental health condition.

Gail P. Hutchings, M.P.A., is the founding President and CEO of the Behavioral Health Policy Collaborative, a private consulting firm based in Alexandria, Virginia, whose clients are public and private sector organizations dedicated to improving mental health and substance abuse systems, services and outcomes. She is a nationally recognized expert on national- and statelevel behavioral health policy and practice as well as effective technical assistance for a wide range of topics and issues. Ms. Hutchings is the former Chief of Staff of the Substance Abuse and Mental Health Services Administration (SAMHSA), a \$3 billion dollar agency in the U.S. Department of Health and Human Services. She is also the past Deputy Executive Director of the National Association of State Mental Health Program Directors. She served as an Alternate Commissioner on the President's New Freedom Commission on Mental Health and was the senior content editor and contributing writer to the Commission's 2003 Final Report, "Achieving the Promise: Transforming Mental Health Care in America." In 2007, Ms. Hutchings was appointed to SAMHSA's Advisory Council on Women's Services and she is also a Foundation Associate in the Women Business Leaders of the U.S. Healthcare Industry Foundation. She is a former Board Member and Summit Chair of the American College of Mental Health Administration. Ms. Hutchings is a published author of several journal articles and book chapters on mental health and behavioral health issues. She holds a Master's Degree in Public Administration with a concentration in public management from the State University of New York at Albany.

- 1. Review background materials ("Futures Plan," current State Plan, etc.)
