This is the Facilitator Jennifer Knauer's understanding of questions that the group is carrying forward, streamlined. If you notice errors or omissions, please make note and bring them to the Working Group Meeting on November 1st, when this conversation will pick up in earnest again.

To determine:

- 1. Where do working group members stand with respect to recommending a 100% Clean Energy Standard vs 100% Renewable Energy Standard?
- 2. As loads increase, how will Vermont look to meet the need?
 - a) What is the right level of new renewables in Vermont?
 - b) What counts as "renewable"?
 - c) *Anticipated Discussion for 11/15 Mtg:* What approaches will result in the most equitable impacts for Vermonters?
- 3. Should there be a time limit or sunset on any of the Renewable Energy Standard provisions? *This question has technical components for Legislative Legal Counsel to research.*

Noted in conversation:

- A. Accepting that RECS / Unbundled RECS are part of the system (regionally). → Of interest here is how to ensure that the use of unbundled RECS isn't hindering new renewables coming online as load needs increase.
- B. Working to figure out how policy reinforces new renewables, while providing flexibility for practical deployment strategies. Trends indicate that as load needs increase, Vermont will be looking to meet demand through new renewables where possible. Observation that Tier One is more workable (given its flexibility and choice) than Tier Two (specific restrictions complicate efforts to balance reliability / affordability / climate goals).
