Your Question:

You requested per student funding amounts for English learners (EL) in state finance systems and for a range of states with the highest and lowest per student funding.

Our Response:

English Learner (EL) funding per student is estimated for states based on their finance mechanism in Tables 1 - 4. A brief description of each table and important caveats are summarized below.

Table 1 estimates per student EL funding for states with categorical grant programs. ECS identified a range from **\$592** in Delaware to a low of **\$48** in West Virginia. Delaware combines funding for low-income students with English learning funding. The per student amount is calculated using both the 2018-2019 EL enrollment (13,164) and the 2018-2019 direct certification enrollment (43,439) for a total enrollment of 56,603.

Table 2 estimates per student EL funding for states with a flat weight. ECS identified a range from **\$7,991** in Maryland to **\$95** in Utah. Weights are expressed as a percentage or a dollar amount. The table includes states with a foundation amount in state statute or in the enacted budget. Other states without a published foundation amount are excluded.

Table 3 estimates per student EL funding for states with multiple weights. ECS identified a range from a maximum weight of **\$4,054** in North Dakota to a minimum weight of **\$105** in Michigan. Similar to Delaware, New York combines EL funding with other student groups. As a result, New York's large amount is not specific to EL spending, but is included in the table for context.

Table 4 estimates per student EL funding for states with both a flat weight and categorical grant(hybrid). ECS identified a range from \$2,929 in Connecticut to \$832 in Colorado.

States that use a resource-based allocation are not included. These states allocate positions to support EL students rather than a per student amount.
