## Goal

As directed by the General Assembly, we are using the principles of a high-quality revenue system to pursue three objectives:

- 1) Analyze Vermont's tax structure
- 2) Recommend improvements and modernization
- 3) Provide a long-term vision

## **Purpose**

We will evaluate Vermont's three major types of taxes – income, consumption, and property – as well as other revenue sources and tax expenditures. We aim to make the tax system more understandable for the public, help policymakers compare the merits of various options, and offer recommendations to help Vermont's revenue system work better for Vermonters.
