## H.871 – An act relating to the development of an updated State aid to school construction program

As recommended by the Senate Committee on Appropriations

#### **Bill Summary**

his bill proposes to:

- 1) Create the Facilities Master Plan Grant Program to support supervisory unions and independent career and technical education districts with the development of a master plan that complies with State construction aid requirements;
- 2) Require the Agency of Education (AOE) and Department of Buildings and General Services (BGS) to work together to establish a list of prequalified architecture and engineering consultants; and
- 3) Create the State Aid for School Construction Working Group to study and design a plan for a statewide school construction aid program.

#### **Fiscal Impact**

As recommended, Section 4 would create the State Aid for School Construction Working Group, with per diem and expense reimbursements authorized for up to six meetings (or up to 10 meetings if additional meetings are jointly authorized by the Speaker of the House and President Pro Tempore of the Senate). Per diems, mileage, and expense reimbursements for the six legislative members of the Group will cost up to an estimated \$15,000 to the General Assembly in fiscal year 2025.

#### **Summary of Provisions with Fiscal Impact**

#### **Section 1: Facilities Master Plan Grant Program**

Section 1 would create a Facilities Master Plan Grant Program to grant funds to supervisory unions and independent career and technical education districts for developing supervisory union-level visions for school buildings. The program would be administered by AOE, which would be tasked with developing standards for disbursing grants based on various criteria. The bill does not contain an appropriation to fund the program. Section 2 would repeal the program on June 30, 2029.

#### Section 4: State Aid for School Construction Working Group; Report

Section 4 would create a seven-member State Aid for School Construction Working Group to study and design a plan for a statewide school construction aid program. The Group would consist of six legislators (three from each body) and the Secretary of Education (or designee).

The Group would be charged with studying and creating a recommended plan for a statewide school construction aid program, including recommendations for implementation. The Group would be authorized to travel to conduct site visits at schools or other states.

The Group would be required to convene its first meeting on or before August 1, 2024, submit its findings and recommendations, in the form of proposed legislation, to the General Assembly by December 15, 2024, and cease to exist on December 31, 2024. Per diem and expense reimbursements would be authorized for up to six meetings unless additional meetings are authorized jointly by the Speaker of the House and the President Pro Tempore of the Senate, with a maximum of up to 10 meetings. These costs are estimated to be up to \$15,000, with actual costs varying based on the number of meetings convened, attendance, and reimbursable expenses.
