H. 97: FY 2019 Sen BAA Proposal Summary

Human Services

- o Adjusts for losses in federal funding including \$2.7m for Woodside.
- o Adjusts for caseload and utilization changes including pressure in DCF child welfare, MH residential and Medicaid and decreases in Reach Up and Aged Blind & Disabled Caseload.
- o Funds contract wage increases for direct care workers (AFSCME).
- o Refunds past overpayment of Vpharm program Rx rebates.
- o DMH Success Beyond Six increase of \$16.2m (match provided from school districts).
- o DOC Adds \$2m GF for Correctional Officer I and II reclassifications.
- o Fiscally neutral move of State Health Care Reserve Fund (SHCRF) of \$277.6m to GF.

Other Budget Areas

- o Judiciary Adds \$200k for expungements of convictions workload.
- Public Safety Adds \$1.77m for sworn officer position reclassifications and other under budgeted expenses.
- o Fish &Wildlife Adds \$115k for 10-year Angler Survey.
- o AOE Adds \$398k for Dual Enrollment increase and updates the education payment estimate.
- o Transportation Authorizes transfer up to \$2.5m to address cost of winter highway maintenance.
- o Tax Lowers the tax computer modernization fund allocation, increasing GF funds available.

One-Time Appropriations

- o Cybersecurity Adds \$1.8m to strengthen the State's data infrastructure.
- o Retirement & OPEB Uses \$22.2m to retire internal retired teachers' health care fund loan initiating pre-funding for this obligation and \$3.3m additional FY20 Teachers' Retirement Fund.
- o Places funds in reserve for FY20 budget process similar to house and administration.

Senate Additions or Modifications

- Carries forward \$800k in Child Care appropriation to FY20 for update to Federal Poverty Level and supplemental grant support; provides \$1.4m one-time grants to providers, and redirects \$300k for lead remediation in licensed child care settings.
- o Provides \$2.5m for lead testing and remediation in schools and childcare settings per S.40.
- Adds \$40k for training of law enforcement officers in fair and impartial policing. Funds onetime equipment and less lethal weapons for State Police. Requires recommendations on video retention policy.
- o Maintains quarter year funding related to sheriffs' contracts in hospitals and requires a report in April from DMH with stake holder input.
- Adds \$435k in Judiciary to replace disallowed Federal child support receipts. Funds AG request of \$22k to address higher caseloads for diversion and pre-trial services.
- o Provides additional \$90k funding for regional economic development grants.
- Reserves funds for child welfare and DOC detention studies. Study specifications to be developed in FY20 budget process.
- o Corrects public inebriates' statutory inconsistencies.
- o Accepts several pending grant and limited service position requests.
