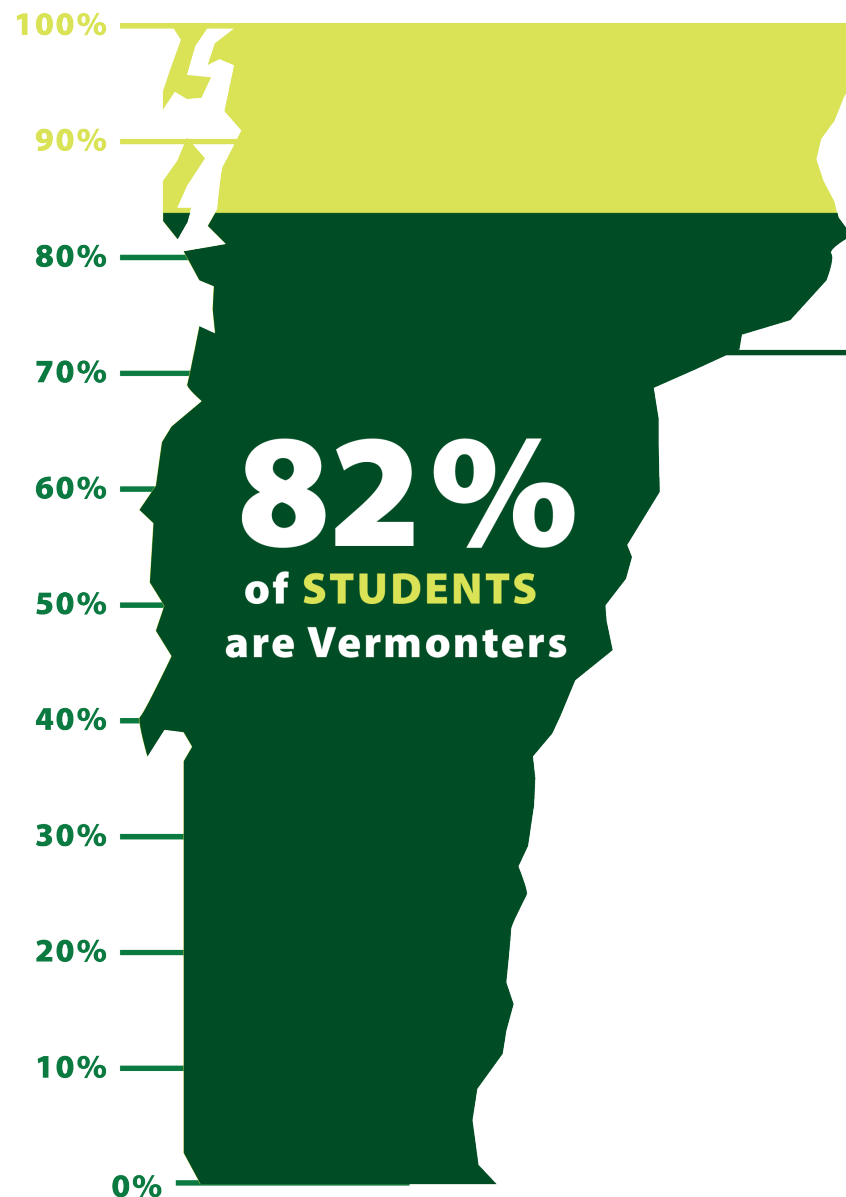

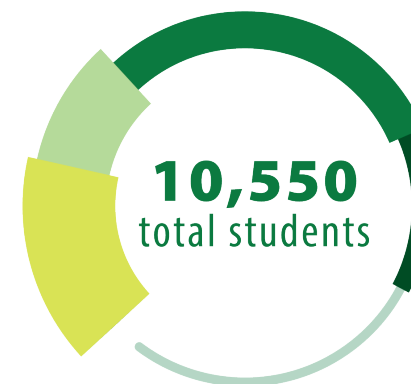
1st Generation Vermonters are enrolled in our undergraduate programs this fall.

Additional Critical Occupations Funds

- FY2022 appropriation: \$5,000,000
- Request: \$2,350,000 additional funds

CTE Program Pilot

- VSC requests language authorizing the use of \$169,123 remaining from Act 80 of 2019 to pilot delivering up to two associates programs at two CTE centers.
- Report due to state in January 2023

Welcome Home Scholarship Authorization

Sec.G300(b)4: \$2,000,000 to the Vermont State Colleges to provide welcome home scholarships of \$5,000 per year or \$2,500 per semester for full-time students enrolled for 12 or more credits, or \$3,000 per year or \$1,500 per semester for part-time students, to Vermonters transferring from out-of-state institutions or returning to school after exiting in 2020–2021. This program’s mission is to incentivize students to come home to Vermont by transferring to Vermont State College System institutions and to complete their degree if they left school without finishing in 2020–2021.

Critical Occupations Plus

- Adds essential programs:
 - Mechanical Engineering
 - Electrical Engineering
 - Graduate Mental Health
 - School Psychology
- Funds eligible non-citizen Vermont residents
- Funds nursing students pursuing a second Bachelor's degree
- Establishes income thresholds
