REVENUE OVERVIEW

In fiscal year 2025, General Fund revenues are expected to be \$17.9M below fiscal 2024 revenues for a total of \$2,113.5M. General Fund revenues in fiscal years 2024 and 2025 are projected to be a cumulative \$111.1M below fiscal year 2023 revenues.

OVERVIEW

This budget addresses many of the ongoing challenges Vermont faces as the state continues to emerge from the COVID-19 pandemic and the upcoming end of related federal funding. It fills all statutorily-required reserves, meets all pension obligations, and makes essential investments in housing, workforce, economic development, human services, and the environment.

To develop this budget, the House Committee on Appropriations worked with House standing committees and many interested stakeholders, including members of the public who testified at public hearings or submitted written testimony. General Fund appropriations total \$2.1B. All funds (unduplicated) appropriations total \$8.6B. Compared to the fiscal year 2024 budget as adjusted by Act 87 (fiscal year 2024 BAA), this reflects a General Fund decrease of \$218.1M and all funds decrease of \$83.3M. This is due to the fact that fewer one-time appropriations were made in fiscal year 2025.

After transparently accounting for the \$12M Vermont State Employees' Retirement System (VSERS) pension "plus" payment, the General Fund in this budget is \$3.3M, or less than 0.2%, higher than the Governor's Recommend.

BASE APPROPRIATIONS

- Sets aside \$31.7M General Fund (GF) in anticipation of the Pay Act
- Fully funds the Department of Public Safety (DPS) contract with the DAs for 12, and adds 4 additional, embedded Mental Health Crisis Specialists
- Provides \$1.1M Global Commitment (GC) to the Department of Mental Health (DMH) for agreements with community providers for crisis management
- Provides \$200K Special Fund (SF) and establishes two permanent positions in the Secretary of State's Office for communications and information technology
- Provides \$204K SF to fund two Cannabis Control Board positions added in Act 87

- Provides \$1.3M GC to the Department of Vermont Health Access (DVHA) to increase reimbursement rates for skilled nursing to Medicare Low Utilization Payment Adjustment (LUPA) rates for the Visiting Nurses Associations of Vermont (VNAs of Vermont)
- Provides \$2.4M GC to DAIL for Meals on Wheels (matched with existing \$1M FF)
- Restores \$9M GF for Child Care Financial Assistance Program (CCFAP) at the Department for Children and Families (DCF) to support programs in Act 76 (2023)
- Adds \$700K GF to the Department of Corrections (DOC) for training contracts

ARPA REALLOCATIONS

If past American Rescue Plan Act (ARPA) appropriations will not meet required obligation deadlines, these appropriations will be reallocated as follows:

- \$36M to DPS Emergency Management for Federal Emergency Management Administration (FEMA) match and municipal support for hazard mitigation
- \$4M for anticipated ARPA audit response
- \$30M to the Vermont Housing and Conservation Board (VHCB) for production and preservation of affordable rental and homeownership units
- \$25M to the Vermont Housing Finance Agency (VHFA) for the Middle-Income Homeownership Development Program and the Vermont Rental Revolving Loan Fund
- Any remaining funds will be reallocated with authorization of the Joint Fiscal Committee to existing State Fiscal Recovery (SFR) programs
- Any unfilled limited service positions funded with ARPA dollars will be abolished on July 1, 2024, and the
 monies will be reverted
