### **OVERVIEW**:

The Committee of Conference report on the budget addresses many of Vermont's ongoing challenges as the State continues to emerge from the COVID-19 pandemic. The budget meets pension, transportation, and clean water obligations, fills all statutorily required reserves, and makes essential investments in housing, workforce, economic development, human services, and the environment. In addition, the budget provides funds for child care. Total unduplicated spending in this budget is \$8.45b. Compared to the FY 2023 budget as adjusted, this reflects a GF increase of \$202.8m and an all funds decrease of \$193.9m. This total includes \$231.1m of one-time GF funds.

#### Prioritize Essential Services and Critical Infrastructure:

Housing - \$211m - (see housing funding summary document)

Funds housing assistance and support programs

Funds continued development of affordable housing units

#### Provider Rate Increases - \$99.7m base total - (see provider rate increase document)

Dental rates increased and cap raised for adult dental services

Primary care, specialty care, FQHC, and free clinic rates increased

Home health provider tax eliminated; rates increased

Assistive Community Care Services, Enhanced Residential Care, Nursing Homes,

Adult Day, and Senior Nutrition rates increased

Designated, Specialized, Substance Use, and TBI provider - 5% rate increase

PNMI, subsidized adoption, and foster care rates increased

EMS - Ambulance rates increased

#### Transportation - FY 2024 new TF fee revenue is \$8m; \$21m annualized

Fee increases effective Jan. 1, 2024

Set to lowest inflation target

#### Criminal Justice System:

Adds a new superior court Judge and 6 additional staff in Judiciary; increases security rate Includes eight new permanent staff in State's Attorneys Office Increases for capacity and ad hoc rates in Defender General Office Fully funds Corrections out of state beds, health care, and payroll cost rollouts Criminal Justice training accreditation process – \$1.2m; three years Community Violence Prevention Program – \$5m; multi-year Bennington youth inpatient residential facility – \$9.2m; multi-year

### Emergency Communications – E-911 and Dispatch Services:

Up to \$2m for technical assistance to DPS Communications Task Force Up to \$4.5m to pilot new regional dispatch centers or expand capacity at existing regional dispatch centers, upon approval of the Joint Fiscal Committee Funds gap in baseline of E-911 Universal Service Fund revenue with \$2.1m transfer
