Enclosed please find four (4) items that the Joint Fiscal Office has received from the administration. Two (2) limited service positions are associated with these requests.

JFO #2704 – One (1) limited service position in the Vermont Department of Health. This position will develop an improved reporting and analysis process for substance abuse prevention activities conducted by field staff and community partners. The position will assume responsibility for much of the federally required data collection work that field staff and community partners currently conduct, allowing them to focus on prevention activities. This position is 100% federally funded with additional Substance Abuse Prevention and Treatment Block Grant funds.

JFO #2705 – \$1,269,582 grant from the Federal Emergency Management Agency to the Vermont Department of Public Safety. These funds will be used to provide Federal disaster assistance in response to the storms and flooding of April 2014 in Caledonia, Essex, Franklin, Lamoille, Orange, Orleans, and Washington Counties.

JFO #2706 – \$50,000 grant from Chipotle Mexican Grill to the Vermont Department of Finance and Management. These funds will a portion of the cover costs associated with implementation and administration of new law that requires labeling of food produced from genetic engineering. The donated funds will be deposited in the Vermont Food Fight Fund.

JFO #2707 – \$50,000 grant from the State Justice Institute to the Vermont Judiciary. These funds will be used to assess courthouse security in Vermont in accordance with Act 179 of 2014 (Sec. E.204.1). Expedited review has been requested. Joint Fiscal Committee members will be contacted by October 8th with a request to waive the balance of the review period and accept this item.

RE: Grant funded position request - SAPT grant'

Please find enclosed a limited service position request form and a classification request. The Health Department is requesting a new position to be funded from the Substance Abuse Prevention and Treatment Block Grant. The annual award has been increased from \$5,093,619 to \$6,032,970. We intend to use 80% of this increased award to fund current substance abuse treatment costs, and the balance to increase prevention activities.

This position will be responsible for developing an improved reporting and analysis process for substance abuse prevention activities conducted by field staff and community grantees. The federal grant has extensive mandatory reporting requirements for community prevention grantees and our field based prevention consultants. This position would assume much of the back office information collection work that must be currently done by the field staff, allowing them to work on higher value community prevention activities.

The block grant will be the primary source of funding for this position initially, but the plan is to implement an integrated data collection system that can meet the needs of other Health Department programs. As other programs use the system, costs will be shared.
