Categorical Exclusion for Vermont Agency of Health Services Planning Division

The recipient agrees to assist OJJDP to comply with the National Environmental Policy Act (NEPA) and other related federal environmental impact analyses requirements in the use of these grant funds either directly by the recipient or by a subrecipient. Accordingly, prior to obligating grant funds, the grantee agrees to first determine if any of the following activities will be related to the use of the grant funds and, if so, to advise OJJDP and request further NEPA implementation guidance. Recipient understands that this special condition applies to its activities whether or not they are being specifically funded with these grant funds. That is, as long as the activity is being conducted by the recipient, a subrecipient, or any third party and the activity needs to be undertaken in order to use these grant funds, this special condition must first be met. The activities covered by this special condition are: a. new construction; b. minor renovation or remodeling of a property either; (1) listed on or eligible for listing on the National Register of Historic Places or; (2) located within a 100-year flood plain; c. a renovation, lease, or any other proposed use of a building or facility that will either; (1) result in a change in its basic prior use or; (2) significantly change its size and; d. Implementation of a new program involving the use of chemicals other than chemicals that are; (1) purchased as an incidental component of a funded activity and; (2) traditionally used, for example, in office, household, recreational, or education environments.

## **Project Abstract**

This project will augment the annual grants made to Vermont communities and state partners through the Children and Family Council for Prevention Programs (CFCPP) and the associated Children's Trust Fund (CTF). The CFCPP or 'Council' is the state advisory group appointed by the Governor under the JJDPA. Its role is to advise on policy and legislation impacting children and youth, and to define priority needs and gaps in the area of delinquency prevention so as to effectively fund primary prevention and intervention projects to address those gaps. The Council has just completed a 3-year plan as required by OJJDP delineating data-based priorities for prevention funding in VT. The Council will emphasize supports to children and families in support of quality education to honor the life long work of Senator James Jeffords in this area.

Funded projects will serve children and youth aged 0 -18 and their families and will focus on early prevention, education, parenting, positive youth development, and sustainability efforts that will support long term viability of effective community programs. Projects will be selected from a competitive pool of applicants emphasizing evidence-based interventions.

Program outcomes and performance measures will be determined at commencement of funding.

Clear program outcomes and performance criteria will be measured quarterly by sub-recipient reports.

#### Statement of the Problem

Listed here are problems and interventions identified as effective and targeted as priorities in the VT OJJDP 3-year plan 2009 - 2011.

OJJDP delinquency prevention and early intervention funds to VT have been cut an estimated 60% since 2002. Community requests for prevention funding outweigh funds by a margin of two to one. Targeted activities will include selections from the following problem and intervention areas:

#### Problem:

- o a systemic childcare subsidy change designed to support low-income working parents will result in the loss of some child care slots,
- o harsh economic conditions cause some parents to choose among competing necessities including after school care for children,
- o the state Department of Education reports significant measurable discrepancy in educational achievement between youth that are, and those that are not living in poverty

Preschool and afterschool enhancements and expansion

## Problem:

- o VT experienced an alarming increase in deaths and life-threatening injuries sustained as a result of shaken baby syndrome in two recent years
- o supports to pregnant and parenting teens are inadequate, programs have exceeded capacity and received budget and staffing cuts, and are not available in all regions of the state
- O Publicly funded substance abuse treatment among youth aged 18 24 years old has increased 65% during the past five years. There are important implications for young parents and youth aged 16 – 18 that can be targeted in delinquency prevention efforts
- o some families that lack the skills and supports needed to raise their adolescent children abandon them to living independently and in unsafe conditions
- o educational achievement of children is directly related to educational achievement of mothers

Educational and family supports to parents –

## Problem:

- o in VT, an estimated 50% of youth over age 16 who commit low-level offenses are processed in the adult criminal justice system resulting in criminal records and resultant long-term negative consequences;
- o community restorative justice interventions in VT have been evaluated as more effective than traditional probation responses (UVM 2007)

o The success rate of community based Court Diversion interventions throughout the state is 82%. In most counties, the Court Diversion option can be used only one time; most youth are referred to Court for a subsequent offense.

Early interventions that prevent at-risk and low-level offending youth from entering the juvenile or criminal justice system –

## Problem:

- o effective youth services must engage youth in planning the course of their own lives
- o an effective justice system would provide developmentally appropriate responses to youth who commit relatively minor criminal offenses including restorative justice responses that keep youth out of the system where warranted, and restore victim and community
- o the 16 17 year old youth who are referred to the adult court and corrections systems for misdemeanor offenses do not receive valid, evidence-based screening and assessment for needs, risks, and strengths as do their peers referred to the juvenile justice system

Workforce development that targets youth workforce, justice officials, and policy makers in positive youth development and adolescent development science and practice can serve as a forum to engage those systems in developing an evidence-based, effective, and developmentally appropriate response to young offenders that will support 1) community safety, 2) victim & community restoration, 3) early interventions for youth where indicated, 4) offense and individually targeted sentences for youth

## Problem:

- o multiple system improvement efforts are just beyond the reach of CTF and DCF to address; part of this Congressional Earmark may be targeted to one of these such as:
- o Court Diversion data base improvement assistance
- o Court Guardian ad Litem sustainability and training needs
- o sub-grantee program performance database accessible to funders and public

The SAG that plans advises and selects CTF grants may choose one of several needed system improvement efforts from these one-time Earmark funds. The July 2009 annual meeting will determine what system improvement effort may be targeted with these funds.

## Impact/Outcomes and Evaluation/Performance Measure Data Collection Plan

## Goals

- Delinquency prevention and systemic improvement efforts aimed at targeted behaviors and conditions as described
- System improvement projects aimed at prioritized system changes in VT juvenile justice and JJDPA SAG grants management

## **Program Objectives**

Objectives will not be defined until proposals are received and selected from a competitive pool of applications. The open RFP will identify problems to be addressed as outlined above.

The overall objectives will be consistent with one of two program areas described in 'goals' above.

#### **Performance Measures**

OJJDP Performance measures relative to one of the two defined program areas will be collected and reported quarterly to grant recipient and annually to OJJDP. These will be defined at program selection and are specified in the attached Logic model for this award.

## Project/Program Design and Implementation

This project will expand the capacity of the VT Children's Trust Fund to provide delinquency prevention funding to communities, or enable a system improvement project that will improve effective services to children, youth, and families.

Competitive RFPs will be publicly distributed to VT community programs and on the state business web site during calendar year 2010. Funding, outcome reports, and evaluation will occur in 2010 and 2011. Evidence-based or empirically supported programs will receive preferential funding. Innovative projects that are based on empirical evidence of prevention and systems change may be funded. Effective programs that emphasize long-term sustainability will receive preferential selection.

Selected projects will receive outcome measurement and Logic model training by program staff before or at commencement of project period.

JJ Specialist will assure reporting of program outcomes as required by OJJDP.

These funds will be utilized in concert with the state 3-year delinquency prevention plan and with a variety of federal, state and private funds.

#### Capabilities/Competencies

This award will be managed by the VT Juvenile Justice Coordinator (aka 'Specialist' in OJJDP lingo) whose primary responsibilities include

- coordination JJDPA and SAG functions in Designated State Agency
- liaison among Designated State Agency, SAG, OJJDP, and sub-recipients
- information dissemination and planning re: youth justice, prevention, and early intervention
- in conjunction with SAG and AHS, assures application, management and /or oversight of
   OJJDP formula and congressional earmark funds received by VT AHS
- manage or coordinate sub-awards and federal reporting
- oversight of state compliance with JJDPA core requirements

The JJ Coordinator is an employee of the VT Agency of Human Services, Department for Children and Families, Family Services, Youth Justice Unit.

A part of SAG-advised OJJDP and other funds are managed in the AHS, DCF, Child Development Division (CDD) with oversight by the After School Systems Director. This position is the CDD liaison to the SAG and the JJ Specialist, connecting early primary prevention efforts with delinquency intervention.

The primary staff are both veterans in their positions with significant experience implementing state and federal programs.

A central AHS / DCF business office manages all grants and fiscal reporting.

The JJDPA SAG, (The Children and Family Council for Prevention Programs) comprised of 21 governor-appointed members with expertise in child welfare, justice, corrections and significant related fields is an active advisory body that

- reviews data and defines service gaps and priorities related to JJDPA and related efforts,
- in partnership with the DSA, issues RFPs to address defined problem areas with effective interventions, reviews proposals and recommends funding to the state
- the SAG monitors sub-recipient progress and outcomes
- the SAG work is accomplished through monthly meetings, sub-committees and additional grant review

Categorical Exclusion for Vermont Agency of Health Services Planning Division

The recipient agrees to assist OJJDP to comply with the National Environmental Policy Act (NEPA) and other related federal environmental impact analyses requirements in the use of these grant funds either directly by the recipient or by a subrecipient. Accordingly, prior to obligating grant funds, the grantee agrees to first determine if any of the following activities will be related to the use of the grant funds and, if so, to advise OJJDP and request further NEPA implementation guidance. #### **Project Abstract**

This project will augment the annual grants made to Vermont communities and state partners through the Children and Family Council for Prevention Programs (CFCPP) and the associated Children's Trust Fund (CTF). The CFCPP or 'Council' is the state advisory group appointed by the Governor under the JJDPA. Its role is to advise on policy and legislation impacting children and youth, and to define priority needs and gaps in the area of delinquency prevention so as to effectively fund primary prevention and intervention projects to address those gaps. The Council has just completed a 3-year plan as required by OJJDP delineating data-based priorities for prevention funding in VT. The Council will emphasize supports to children and families in support of quality education to honor the life long work of Senator James Jeffords in this area.

Funded projects will serve children and youth aged 0 -18 and their families and will focus on early prevention, education, parenting, positive youth development, and sustainability efforts that will support long term viability of effective community programs. Projects will be selected from a competitive pool of applicants emphasizing evidence-based interventions.

Program outcomes and performance measures will be determined at commencement of funding.

Clear program outcomes and performance criteria will be measured quarterly by sub-recipient reports.

#### Statement of the Problem

Listed here are problems and interventions identified as effective and targeted as priorities in the VT OJJDP 3-year plan 2009 - 2011.

OJJDP delinquency prevention and early intervention funds to VT have been cut an estimated 60% since 2002. Community requests for prevention funding outweigh funds by a margin of two to one. Targeted activities will include selections from the following problem and intervention areas:

#### Problem:

- o a systemic childcare subsidy change designed to support low-income working parents will result in the loss of some child care slots,
- o harsh economic conditions cause some parents to choose among competing necessities including after school care for children,
- o the state Department of Education reports significant measurable discrepancy in educational achievement between youth that are, and those that are not living in poverty

Preschool and afterschool enhancements and expansion

## Problem:

- O VT experienced an alarming increase in deaths and life-threatening injuries sustained as a result of shaken baby syndrome in two recent years
- o supports to pregnant and parenting teens are inadequate, programs have exceeded capacity and received budget and staffing cuts, and are not available in all regions of the state
- Publicly funded substance abuse treatment among youth aged 18 24 years old
  has increased 65% during the past five years. There are important implications for
  young parents and youth aged 16 18 that can be targeted in delinquency
  prevention efforts
- o some families that lack the skills and supports needed to raise their adolescent children abandon them to living independently and in unsafe conditions
- o educational achievement of children is directly related to educational achievement of mothers

Educational and family supports to parents –

## Problem:

- o in VT, an estimated 50% of youth over age 16 who commit low-level offenses are processed in the adult criminal justice system resulting in criminal records and resultant long-term negative consequences;
- o community restorative justice interventions in VT have been evaluated as more effective than traditional probation responses (UVM 2007)

o The success rate of community based Court Diversion interventions throughout the state is 82%. In most counties, the Court Diversion option can be used only one time; most youth are referred to Court for a subsequent offense.

Early interventions that prevent at-risk and low-level offending youth from entering the juvenile or criminal justice system –

### Problem:

- o effective youth services must engage youth in planning the course of their own lives
- o an effective justice system would provide developmentally appropriate responses to youth who commit relatively minor criminal offenses including restorative justice responses that keep youth out of the system where warranted, and restore victim and community
- o the 16 17 year old youth who are referred to the adult court and corrections systems for misdemeanor offenses do not receive valid, evidence-based screening and assessment for needs, risks, and strengths as do their peers referred to the juvenile justice system

Workforce development that targets youth workforce, justice officials, and policy makers in positive youth development and adolescent development science and practice can serve as a forum to engage those systems in developing an evidence-based, effective, and developmentally appropriate response to young offenders that will support 1) community safety, 2) victim & community restoration, 3) early interventions for youth where indicated, 4) offense and individually targeted sentences for youth

### Problem:

- o multiple system improvement efforts are just beyond the reach of CTF and DCF to address; part of this Congressional Earmark may be targeted to one of these such as:
- o Court Diversion data base improvement assistance
- o Court Guardian ad Litem sustainability and training needs
- o sub-grantee program performance database accessible to funders and public

The SAG that plans advises and selects CTF grants may choose one of several needed system improvement efforts from these one-time Earmark funds. The July 2009 annual meeting will determine what system improvement effort may be targeted with these funds.

### Impact/Outcomes and Evaluation/Performance Measure Data Collection Plan

### Goals

- Delinquency prevention and systemic improvement efforts aimed at targeted behaviors and conditions as described
- System improvement projects aimed at prioritized system changes in VT juvenile justice and JJDPA SAG grants management

# **Program Objectives**

Objectives will not be defined until proposals are received and selected from a competitive pool of applications. The open RFP will identify problems to be addressed as outlined above.

The overall objectives will be consistent with one of two program areas described in 'goals' above.

### **Performance Measures**

OJJDP Performance measures relative to one of the two defined program areas will be collected and reported quarterly to grant recipient and annually to OJJDP. These will be defined at program selection and are specified in the attached Logic model for this award.

# Project/Program Design and Implementation

This project will expand the capacity of the VT Children's Trust Fund to provide delinquency prevention funding to communities, or enable a system improvement project that will improve effective services to children, youth, and families.

Competitive RFPs will be publicly distributed to VT community programs and on the state business web site during calendar year 2010. Funding, outcome reports, and evaluation will occur in 2010 and 2011. Evidence-based or empirically supported programs will receive preferential funding. Innovative projects that are based on empirical evidence of prevention and systems change may be funded. Effective programs that emphasize long-term sustainability will receive preferential selection.

Selected projects will receive outcome measurement and Logic model training by program staff before or at commencement of project period.

JJ Specialist will assure reporting of program outcomes as required by OJJDP.

These funds will be utilized in concert with the state 3-year delinquency prevention plan and with a variety of federal, state and private funds.

### Capabilities/Competencies

This award will be managed by the VT Juvenile Justice Coordinator (aka 'Specialist' in OJJDP lingo) whose primary responsibilities include

- coordination JJDPA and SAG functions in Designated State Agency
- liaison among Designated State Agency, SAG, OJJDP, and sub-recipients
- information dissemination and planning re: youth justice, prevention, and early intervention
- in conjunction with SAG and AHS, assures application, management and /or oversight of
   OJJDP formula and congressional earmark funds received by VT AHS
- manage or coordinate sub-awards and federal reporting
- oversight of state compliance with JJDPA core requirements

The JJ Coordinator is an employee of the VT Agency of Human Services, Department for Children and Families, Family Services, Youth Justice Unit.

A part of SAG-advised OJJDP and other funds are managed in the AHS, DCF, Child Development Division (CDD) with oversight by the After School Systems Director. This position is the CDD liaison to the SAG and the JJ Specialist, connecting early primary prevention efforts with delinquency intervention.

The primary staff are both veterans in their positions with significant experience implementing state and federal programs.

A central AHS / DCF business office manages all grants and fiscal reporting.

The JJDPA SAG, (The Children and Family Council for Prevention Programs) comprised of 21 governor-appointed members with expertise in child welfare, justice, corrections and significant related fields is an active advisory body that

- · reviews data and defines service gaps and priorities related to JJDPA and related efforts,
- in partnership with the DSA, issues RFPs to address defined problem areas with effective interventions, reviews proposals and recommends funding to the state
- the SAG monitors sub-recipient progress and outcomes
- the SAG work is accomplished through monthly meetings, sub-committees and additional grant review

Congratulations on your recent award. In establishing financial assistance programs, Congress linked the receipt of Federal funding to compliance with Federal civil rights laws. The Office for Civil Rights (OCR), Office of Justice Programs (OJP), U.S. Department of Justice is responsible for ensuring that recipients of financial aid from OJP, its component offices and bureaus, the Office on Violence Against Women (OVW), and the Office of Community Oriented Policing Services (COPS) comply with applicable Federal civil rights statutes and regulations. We at OCR are available to help you and your organization meet the civil rights requirements that come with Justice Department funding.

#### **Ensuring Access to Federally Assisted Programs**

As you know, Federal laws prohibit recipients of financial assistance from discriminating on the basis of race, color, national origin, religion, sex, or disability in funded programs or activities, not only in respect to employment practices but also in the delivery of services or benefits. Federal law also prohibits funded programs or activities from discriminating on the basis of age in the delivery of services or henefits.

### Providing Services to Limited English Proficiency (LEP) Individuals

In accordance with Department of Justice Guidance pertaining to Title VI of the Civil Rights Act of 1964, 42 U.S.C. § 2000d, recipients of Federal financial assistance must take reasonable steps to provide meaningful access to their programs and activities for persons with limited English proficiency (LEP). For more information on the civil rights responsibilities that recipients have in providing language services to LEP individuals, please see the website at http://www.lep.gov.

### **Ensuring Equal Treatment for Faith-Based Organizations**

The Department of Justice has published a regulation specifically pertaining to the funding of faith-based organizations. In general, the regulation, Participation in Justice Department Programs by Religious Organizations; Providing for Equal Treatment of all Justice Department Program Participants, and known as the Equal Treatment Regulation 28 C.F.R. part 38, requires State Administering Agencies to treat these organizations the same as any other applicant or recipient. The regulation prohibits State Administering Agencies from making award or grant administration decisions on the basis of an organization's religious character or affiliation, religious name, or the religious composition of its board of directors.

The regulation also prohibits faith-based organizations from using financial assistance from the Department of Justice to fund inherently religious activities. While faith-based organizations can engage in non-funded inherently religious activities, they must be held separately from the Department of Justice funded program, and customers or beneficiaries cannot be compelled to participate in them. The Equal Treatment Regulation also makes clear that organizations participating in programs funded by the Department of Justice are not permitted to discriminate in the provision of services on the basis of a beneficiary's religion. For more information on the regulation, please see OCR's website at http://www.ojp.usdoj.gov/ocr/etfbo.htm.

State Administering Agencies and faith-based organizations should also note that the Safe Streets Act, as amended; the Victims of Crime Act, as amended; and the Juvenile Justice and Delinquency Prevention Act, as amended, contain prohibitions against discrimination on the basis of religion in employment. Despite these nondiscrimination provisions, the Justice Department has concluded that the Religious Freedom Restoration Act (RFRA) is reasonably construed, on a case-by-case basis, to require that its funding agencies permit faith-based organizations applying for funding under the applicable program statutes both to receive DOJ funds and to continue considering religion when hiring staff, even if the statute that authorizes the funding program generally forbids considering of religion in employment decisions by grantees.

Questions about the regulation or the application of RFRA to the statutes that prohibit discrimination in employment may be directed to this Office.

### **Enforcing Civil Rights Laws**

All recipients of Federal financial assistance, regardless of the particular funding source, the amount of the grant award, or the number of employees in the workforce, are subject to the prohibitions against unlawful discrimination. Accordingly, OCR investigates recipients that are the subject of discrimination complaints from both individuals and groups. In addition, based on regulatory criteria, OCR selects a number of recipients each year for compliance reviews, audits that require recipients to submit data showing that they are providing services equitably to all segments of their service population and that their employment practices meet equal employment opportunity standards.

### Complying with the Safe Streets Act or Program Requirements

In addition to these general prohibitions, an organization which is a recipient of financial assistance subject to the nondiscrimination provisions of the Omnibus Crime Control and Safe Streets Act (Safe Streets Act) of 1968, 42 U.S.C. § 3789d(c), or other Federal grant program requirements, must meet two additional requirements:(1) complying with Federal regulations pertaining to the development of an Equal Employment Opportunity Plan (EEOP), 28 C.F.R. § 42.301-.308, and (2) submitting to OCR Findings of Discrimination (see 28 C.F.R. §§ 42.205(5) or 31.202(5)).

### 1) Meeting the EEOP Requirement

In accordance with Federal regulations, Assurance No. 6 in the Standard Assurances, COPS Assurance No. 8.B, or certain Federal grant program requirements, your organization must comply with the following EEOP reporting requirements:

If your organization has received an award for \$500,000 or more and has 50 or more employees (counting both full- and part-time employees but excluding political appointees), then it has to prepare an EEOP and submit it to OCR for review within 60 days from the date of this letter. For assistance in developing an EEOP, please consult OCR's website at http://www.ojp.usdoj.gov/ocr/eeop.htm. You may also request technical assistance from an EEOP specialist at OCR by dialing (202) 616-3208.

If your organization received an award between \$25,000 and \$500,000 and has 50 or more employees, your organization still has to prepare an EEOP, but it does not have to submit the EEOP to OCR for review. Instead, your organization has to maintain the EEOP on file and make it available for review on request. In addition, your organization has to complete Section B of the Certification Form and return it to OCR. The Certification Form can be found at http://www.ojp.usdoj.gov/ocr/eeop.htm.

If your organization received an award for less than \$25,000; or if your organization has less than 50 employees, regardless of the amount of the award; or if your organization is a medical institution, educational institution, nonprofit organization or Indian tribe, then your organization is exempt from the EEOP requirement. However, your organization must complete Section A of the Certification Form and return it to OCR. The Certification Form can be found at http://www.ojp.usdoj.gov/ocr/eeop.htm.

### 2) Submitting Findings of Discrimination

In the event a Federal or State court or Federal or State administrative agency makes an adverse finding of discrimination against your organization after a due process hearing, on the ground of race, color, religion, national origin, or sex, your organization must submit a copy of the finding to OCR for review.

#### **Ensuring the Compliance of Subrecipients**

If your organization makes subawards to other agencies, you are responsible for assuring that subrecipients also comply with all of the applicable Federal civil rights laws, including the requirements pertaining to developing and submitting an EEOP, reporting Findings of Discrimination, and providing language services to LEP persons. State agencies that make subawards must have in place standard grant assurances and review procedures to demonstrate that they are effectively monitoring the civil rights compliance of subrecipients.
