No Joint Fiscal Committee member has requested that the following items be held for review:

JFO #2517 — \$5,225,186 grant from the U.S. Federal Emergency Management Agency (FEMA) to the Vermont Agency of Transportation. These funds will be used to provide disaster assistance for damages cause by severe storms and flooding during spring 2011 in Addison, Chittenden, Essex, Franklin, Grand Isle, Lamoille, Orleans, Washington, Caledonia, Essex, and Orange counties. [*JFO received 8/10/11*]

JFO #2518 — \$12,642,000 transfer from the University of Vermont to the Vermont Agency of Human Services. These funds will be used to earn federal matching Medicaid funds for Graduate Medical Education. This funding was appropriated to UVM, but must be transferred back to AHS in order to be eligible for federal match. [*JFO received 8/10/11*]

JFO #2519 — \$100,000 grant from the U.S. Department of Labor to the Vermont Department of Public Safety. These funds will be used to provide assistance to local fire and emergency medical service organizations for youth emergency service training programs and to develop adult recruitment and retention strategies. [JFO received 8/10/11]

JFO #2520 — \$80,000 donation from Rolf Kielman and Stephanie Spencer to the Vermont Department of Fish and Wildlife. This amount represents the difference between the \$120,000 market value of the conservation easements and the selling price of \$40,000. [*JFO received 8/10/11*]

Enclosed please find five (5) items that the Joint Fiscal Office has received from the administration. One limited service position request is included among these items.

JFO #2517 — \$5,225,186 grant from the U.S. Federal Emergency Management Agency (FEMA) to the Vermont Agency of Transportation. These funds will be used to provide disaster assistance for damages cause by severe storms and flooding during spring 2011 in Addison, Chittenden, Essex, Franklin, Grand Isle, Lamoille, Orleans, Washington, Caledonia, Essex, and Orange counties. JFO #2518 — \$12,642,000 transfer from the University of Vermont to the Vermont Agency of Human Services. These funds will be used to earn federal matching Medicaid funds for Graduate Medical Education. This funding was appropriated to UVM, but must be transferred back to AHS in order to be eligible for federal match. [*JFO received 8/10/11*]

JFO #2519 — \$100,000 grant from the U.S. Department of Labor to the Vermont Department of Public Safety. These funds will be used to provide assistance to local fire and emergency medical service organizations for youth emergency service training programs and to develop adult recruitment and retention strategies. [JFO received 8/10/11]

JFO #2520 — \$80,000 donation from Rolf Kielman and Stephanie Spencer to the Vermont Department of Fish and Wildlife. This amount represents the difference between the \$120,000 market value of the conservation easements and the selling price of \$40,000. [*JFO received 8/10/11*]

JFO #2521 — Request to establish **one limited service position** in the Department of Environmental Conservation (DEC). The position is necessary to meet federal data management requirements of the Water Quality Monitoring, Assessment & Planning Program [*JFO received 8/22/11*]

Dear Mr. President:

I respectfully request that my request for a Major Disaster Declaration dated May 27, 2011 be amended to include Washington County for Individual Assistance and Caledonia County for Public Assistance. As discussed in my original request, I have determined that severe storms and flooding impacting Vermont since April 23, 2011, are of such severity and magnitude that effective response is beyond the capabilities of state and local governments and that supplementary federal assistance is necessary.

Over the period of May 26-27, 2011, these counties received over four inches of rain to soil that is already saturated. The city and town of Barre (Washington County) is placed under a heightened risk of landslides. The City has evacuated homes and several are in the process of being condemned or found uninhabitable. Three shelters were established in the Central Vermont area and as the need has changed, one shelter remains open. The highest numbers of sheltered persons was 112 and currently 16 people remain in the shelter in Barre City. The City and Town experienced flooding which included the downtown areas. An IA PDA has been scheduled for June 2, 2011. The city of Barre is reporting: 29 destroyed, 92 with major damage and 98 with minor damage from a preliminary survey. In the Town of Berlin (Washington County) a trailer park flooded and the residents had to be sheltered.

Caledonia County experienced this storm and has requested through Vermont Emergency Management damage assessment as a result of significant damage with their infrastructure.

I certify that for this major disaster, the State and local governments will assume all applicable non-Federal share of costs required by the Stafford Act. Total expenditures are expected to exceed \$1,240,520.25 in accordance with the table in Enclosure D on the original request and Enclosure B on the amended request.

I request direct Federal assistance for work and services to saves lives and property.

- (a) Existing budgetary concerns even prior to the incident at both State and local levels made funding the response a challenge. The threat of additional damage caused by flooding, particularly increased landslide potential, suggests federal support is necessary.
- (b) Assistance is requested for flood fighting and debris removal

In accordance with 44 CFR § 206.208, the State of Vermont agrees that it will, with respect to direct Federal assistance:

- 1. Provide without cost to the United States all lands, easements and right-of-ways necessary to accomplish the approved work;
- 2. Hold and save the United States free from damages due to the requested work, and shall indemnify the Federal Government against any claims arising from such work;
- 3. Provide reimbursement to FEMA for the non-Federal share of the cost of such work in accordance with the provisions of the FEMA-State Agreement; and
- 4. Assist the performing Federal agency in all support and local jurisdictional matters.

In addition, I anticipate the need for debris removal, which poses an immediate threat to lives, public health, and safety.

Pursuant to Sections 403 and 407 of the Stafford Act U.S.C. §§ 517b & 5173, the State agrees to indemnify and hold harmless the United States of America for any claims arising from the removal of debris or wreckage for this disaster. The State agrees that

GOVERNOR'S REQUEST MAJOR DISASTER

Dear Mr. President:

Under the provisions of Section 401 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. §§ 5121-5208 (Stafford Act), and implemented by 44 CFR § 206.36, I request that you declare a major disaster for the State of Vermont as a result of severe flooding beginning April 23, 2011 and continuing. Damages are still occurring due to river flooding and sustained record high water levels in Lake Champlain. Record snowpack and precipitation in March through May led to rising water in Lake Champlain. The damages received beginning April 23, 2011 were exacerbated when winds gusting to 50 miles per hour hammered south-facing shorelines. Flooding and lake levels continued to rise into the following week when a significant rain event on April 26-27th affected the northern half of the state causing flash flooding along the Lamoille, Missisquoi, Passumspic, and Winooski river basins. This amount of rain totaling 2-4 inches caused sharp rises in rivers and streams because of the already saturated ground conditions. Damages included road washouts and flooding to homes and businesses in all counties of Vermont, All of the previously stated river basins drain into Lake Champlain and caused additional lake area flooding to occur. Another storm moved through the Lake Champlain drainage basin on May 3-4th causing the lake to rise above levels that had already surpassed all historical records. The Lake has crested as of May 8, 2011 at more than 3 feet above flood stage and is forecasted to remain above flood stage for several weeks, if not months. Higher than normal rainfall has continued through the month of May, making this the wettest spring on record in Vermont. This has caused water tables to be higher than normal and has significantly increased the risk of flash flooding whenever rain moves through the area. On Friday, May 20th thunderstorms moved through the state and caused flash flooding. Towns in Addison, Franklin, Washington and Windham counties incurred even more damages and washouts that closed roads and cut off homeowners from emergency access. Another round of thunderstorms in this weather pattern moved through the state overnight on May 26th and caused severe flooding including road washouts and public infrastructure damage in Caledonia, Orange, Washington. As the water table remains high through this continued weather pattern, so will the risk of flooding.

In response to the situation, I have taken appropriate action under State law and directed the execution of the State Emergency Operations Plan through the Commissioner of the Department of Public Safety on

April 23, 2011 in accordance with Section 401 of the Stafford Act. I have also issued an executive order declaring that a State of Emergency exists beginning on May 5, 2011 for the entire State of Vermont.

The State of Vermont has a State Hazard Mitigation Plan that was approved by FEMA in November of 2010. Approximately 85% of Vermont communities have FEMA approved standard local mitigation plans or are in draft stages prior to approval.

On May 4, 2011, I requested a joint Federal, State, and local survey of the damaged areas for public infrastructure in the counties of Addison, Chittenden, Essex, Franklin, Grand Isle, Lamoille and Orleans. Preliminary assessments indicated the most severe impacts were to roads and bridges near waterways as well as residences and businesses that continue to be surrounded by water along the shorelines of Lake Champlain. On May 10, 2011 and May 24, 2011, I requested the addition of Washington and Windham counties respectively to the joint damage assessment. The preliminary damage assessments for public infrastructure damage confirmed approximately \$4.1 million in damage although total damage estimates submitted by local jurisdictions reached as much as \$8.3 million. In addition to the confirmed amount of damages to public infrastructure there was also over \$3 million in damages to the federal highway system. As the water levels have risen, causeways and roads that connect local jurisdictions near the northern part of the lake have had to be built up to sustain access. Flooding caused state and local roads closures in at least 70 local jurisdictions over the duration of the event. During the April 26-27th rain storm, schools were closed in Lamoille, Chittenden, and Franklin counties due to dangerous routes of travel. Several businesses were flooded including one grocery store that services several small towns. Many businesses along the lake remain closed or have experienced business loss due to less than normal seasonal customer use. The towns of Alburgh, Grand Isle, Johnson, North Hero, Waitsfield and St. Albans declared a state of emergency. Vermonters have heeded the safety advice of local and state officials, so to this point there has been no storm related deaths or injuries.

In addition to the preliminary damage assessment for public infrastructure, I requested a joint preliminary damage assessment for individual and homeowner damages on May 11, 2011. To date, at least 77 homes have suffered major damage and 109 have suffered minor damage as confirmed by the joint preliminary damage assessments. Vermont 211 has collected over 600 damage reports from homeowners. Because the lake is receding very slowly, there are still 109 homes the assessment teams were not able to access. Therefore because water has been standing in those homes for weeks, it is likely that many of them will be found to have experienced major damage. Hundreds of the homes on Lake Champlain have contaminated wells and water supplies as well as septic systems that are badly damaged from spending weeks under water. Hundreds of people have been temporarily displaced because of both the river and the lake flooding. Most of these people are staying with friends and relatives until they are able to be back in their own homes. A shelter was opened in the Town of St. Albans to assist displaced people from the shore for a May 2 through May 5. Shelters in Barre City and Montpelier are currently open for over 200 evacuated people from flooding in the area on May 26th.

The economic impact of this extended incident is widespread. This disaster comes on heels of a wind storm disaster this previous winter that affected many of the same areas that have been hit as a result of the flooding. Local jurisdictions are still recovering from the wind storm that caused severe public infrastructure damage. At least three state parks and several town and city recreational areas will not be able to open on time (Memorial Day weekend) because of the Lake Champlain water level. There is a chance that some of them may not open at all this summer. There is an abundance of rental properties along the lake that are routinely occupied for vacation purposes. It is uncertain when those properties will be available again due to extended access challenges and projected repairs needed to make the property habitable. All over the northern part of the state excavation companies and contractors are behind schedule in the start of the construction season because of saturated ground that has made it too dangerous to work. Restaurants, ferry services, grocers and novelty store owners are either opening late or will not

open at all due to the level of damages incurred along the lake front. Summer camps for children and private camping grounds including motor home parks have had to delay opening until the water level recedes. During the height of the river flooding on April 26th-27th staff in several area hospitals either could not get to work or could not make it home, so hotels in the area offered lower rates to workers. Farms and growers have experienced an extremely difficult start to the season. Planting times for most farmers have been delayed because of the wet conditions in the fields or because the fields are still flooded. Farmers' fields experienced nutrient loss as fertilizer has been washed away in storm runoff. Fruit growers have not been able to treat their crops because of the dangerous conditions in the orchards and this will result in crop loss later in the summer. All of these factors have contributed to an economic hit that will be difficult to recover from and will continue as long as the water levels stay where they are.

The rural nature of Vermont (average people per square mile is 67 which is well below the national average if 87) challenges both response and recovery efforts at the state and local levels in austere budgetary and staffing circumstances. Most of the towns within the counties affected operate on a very small budget with minimal full time staff. The magnitude and extended nature of the event has reached the point where the abilities of personnel to handle response are overwhelmed. The state is also operating with a budget shortfall and is not able to assist local jurisdictions as they once may have in recent years. Without assistance, roads and bridges as well as homes and businesses will take much longer to be repaired, which affects the safety of the citizens of Vermont. I am specifically requesting Public Assistance for the counties of Addison, Chittenden, Essex, Franklin, Grand Isle, Lamoille, Orleans, Washington and Windham. Vermont does not often request Individual Assistance but in this case the incident impact is such that a request is warranted for the Individuals and Households Program, Disaster Unemployment Assistance, Crisis Counseling, Disaster Legal Services, and Internal Revenue Services in the counties of Addison, Chittenden, Essex, Franklin, Grand Isle, Lamoille, and Orleans and Small Business Administration Disaster Loans in all counties. I am also requesting Hazard Mitigation assistance statewide.

As the table below shows, the affected counties have levels of poverty almost double the national average and unemployment rates exceeding the national average. Without Federal assistance, the affected individuals cannot effectively recover from this event.

Preliminary estimates of the types and amount of assistance needed under the Stafford Act are tabulated in Enclosures A and B. Estimated requirements for assistance from certain Federal agencies under other statutory authorities are tabulated in Enclosure C.

The following information is furnished on the nature and amount of State and local resources that have been or will be used to alleviate the conditions of this disaster. No other federal agencies responded under their own authorities or at the request of the state. Several state agencies and organizations were directed to provide assistance as a result of the storm. The State Emergency Operations Center has been activated at a Level 2 and Level 3 for normal business hours to support response activities for the duration of the event. The Department of Public Safety, Division of Emergency Management coordinated state-level emergency response and recovery activities. A staging area was established for a few days to support the response in Franklin and Grand Isle counties. This included high water vehicle assets, stand-by troops and medevac helicopter availability from the Vermont National Guard and Vermont State Police command assets including the Mobile Command Post. The Vermont National Guard has assigned 12 additional high-water vehicles to assist local jurisdiction currently affected by the flooding on May 26th with evacuations of homeowners. The Department of Buildings and General Services and the National Guard provided sandbags and sandbagging support for multiple jurisdictions throughout the incident period. The total amount of sandbags provided for local jurisdictions was approximately 107,000. Vermont Department of Buildings and General Services also responded to state facilities that needed repairs due to flooding. Community Emergency Response Teams were activated for both traffic control and sandbagging missions. The Vermont Agency of Transportation accomplished multiple large scale emergency road repairs and sustained access to key facilities and jurisdictions. They also participated in the joint preliminary damage assessments for damage to public infrastructure. The Vermont State Police monitored the situation on the ground statewide and reported initial damages and road closures for enhanced situational awareness. Vermont Agency of Human Services and American Red Cross responded to human service needs including sheltering and client services. The Agency of Human Services has coordinated with state officials for the joint preliminary damage assessment to individual homes. The American Red Cross has also been assisting with mass care to emergency responders and displaced people as well as conducting state damage assessments. Throughout the incident period, the Red Cross has provided 698 meals and 1248 snacks to emergency workers and displaced people. They distributed 15 cleanup kits and 64 comforts kits and assisted 92 clients who were affected as a result of this disaster. Many of the displaced people are still living with family and friends until it is safe for them to go back into their homes. As a result of the continued flooding on May 26th two Red Cross shelters are open servicing over 200 people. Vermont Department of Health monitored health care facilities and issued guidance on the use of wells and septic systems that experienced flooding to avoid contaminated water. They have also issued tests for contaminated wells and water supplies to homeowners. Vermont Department of Public Service assisted with coordinating utility situational awareness and needs. Electrical disconnects to customers experiencing flooding totaled 3,773 and some continue to remain off because of lake flooding, Vermont Agency of Agriculture assisted in the dissemination of information to farmers about delayed milk transportation and coordinated support for farmers who have experienced delays in planting times. Vermont Division of Fire Safety provided building inspection teams for flooded buildings and will continue to do so as the water recedes. The Vermont Agency of Natural Resources coordinated information about flooded public infrastructure as well as the status of many dams around the state. They will continue to work in developing a debris clearance and management strategy to address the issues in the coming weeks. Vermont 2-1-1 continues to provide referrals for individuals seeking resources for flood cleanup and assistance as well as acting at the main call center for reporting of individual damages. The Vermont Voluntary Organizations Active in Disasters (VT VOAD) is assisting with home muck-outs and cleaning for flooded homes. Finally, local and state emergency responders and road crews have worked tirelessly for weeks on end mitigating further damages to public infrastructure and protecting the lives of the citizens of Vermont. A complete description of the storm has been provided by the National Weather Service office that services most of Vermont is attached as Enclosure E.

I certify that for this major disaster, the State and local governments will assume all applicable non-Federal share of costs required by the Stafford Act. Total expenditures are expected to exceed \$1,042,082, in accordance with the table in Enclosure D.

I request direct Federal assistance for work and services to save lives and protect property.

(a). Existing budgetary concerns even prior to the incident at both the state and local levels made funding the response a challenge. The threat of additional damage caused by flooding, particularly along Lake Champlain, suggests that federal support is necessary.

(b). Assistance is requested for flood-fighting and debris removal...

In accordance with 44 CFR § 206.208, the State of Vermont agrees that it will, with respect to direct Federal assistance:

- 1. Provide without cost to the United States all lands, easements and rights-of-ways necessary to accomplish the approved work;
- 2. Hold and save the United States free from damages due to the requested work, and shall indemnify the Federal Government against any claims arising from such work;
- 3. Provide reimbursement to FEMA for the non-Federal share of the cost of such work in accordance with the provisions of the FEMA-State Agreement; and
- 4. Assist the performing Federal agency in all support and local jurisdictional matters.

In addition, I anticipate the need for debris removal, which poses an immediate threat to lives, public health, and safety.

Pursuant to Sections 403 and 407 of the Stafford Act, 42 U.S.C. §§ 5170b & 5173, the State agrees to indemnify and hold harmless the United States of America for any claims arising from the removal of debris or wreckage for this disaster. The State agrees that debris removal from public and private property will not occur until the landowner signs an unconditional authorization for the removal of debris.

I have designated Michael E. O'Neil, Director, Vermont Emergency Management, as the State Coordinating Officer for this request. He/she will work with the Federal Emergency Management Agency in damage assessments and may provide further information or justification on my behalf.

Weather Summary of Multiple Flood Events across Vermont from 23 April 2011 to Present (On-going Event)

Weather Summary and River Flooding

The flooding across Vermont and the Lake Champlain basin during April and May was a result of abnormally high winter snowfall, significant snow melt of that snowfall and record rainfall for meteorological spring (March, April, May) as well as monthly precipitations records for April and May.

Figure 1 shows the precipitation totals for March, April and May 2011 as compared to climatology as well as historical records (established since 1883) for Burlington, Vermont.

The winter of 2010-11 was an "old-fashioned" North Country winter with abnormally high snowfall and the lack of a significant mid-winter thaw. The NWS Burlington office measured 128.4 inches of snowfall (Normal is 81 inches), the third highest totals since records have been established in 1883.

In mid-March, snow depths in Vermont ranged from 8 to 20 inches in the valleys, 18 to 36 inches between 1000 to 2000 feet and 40 to 80+ inches above 2500 feet. Water equivalent of this snow pack ranged 2 to 6 inches, 4 to 8 inches and 10 to 15+ inches respectively.

During late March-early April, snow melt and rainfall was routine with streams and rivers running at or above normal. Lake Champlain's lake level rose from 96 feet in early March to 99 feet by April 10th (Figure 2). Flood stage is considered to be 100 feet.

On April 11-12th, a moderate rainfall event delivered 1 to 1.5 inches of rainfall to Vermont, accompanied by temperatures in the 60s and 70s that enhanced snow melt. This caused many river levels to approach or exceed bankfull with some minor flooding and pushed Lake Champlain above its' flood stage of 100 feet.

The last few weeks of April featured several rainfall events that totaled 2.5 to 5+ inches from Addison, Washington and Caledonia counties north to the Canadian border.

April 26th-27th

The heaviest rainfall and resulting major flood event occurred during the night of the 26th into the early morning hours of the 27th, where 2 to 4 inches of rain occurred across the northern third of the state due to training showers and thunderstorms (Figure 3). Numerous reports and degrees of flooding occurred on April 27th with localized flash flooding, widespread areal flooding, major river flooding and major flooding along the shores of Lake Champlain. Some of the hardest hit locations included Chittenden, Franklin, Lamoille, Orleans, Essex and Caledonia counties.

The Lamoille River at Johnson peaked at 16.97 feet (Flood Stage is 13 feet), the 4th highest level and equivalent to a 25 to 50 year flood event. Major flooding occurred along the Lamoille River in Johnson, Cambridge, Jeffersonville as well as along the Gihon and Browns rivers.

The Missisquoi River basin witnessed flooding from North Troy to Lake Champlain.

At North Troy, the river peaked at 12.95 feet (Flood stage is 9 feet), nearly a foot above major flood stage and the 4th highest recorded level. Significant flooding occurred in the North Troy-Westfield area. This is estimated to be a 100 year flood event.

The Passumpsic River basin witnessed flooding, especially near the headwater region in Lyndon. The East Branch of the Passumpsic River at East Haven peaked at 9.10 feet (Flood stage is 6.5 feet), the 4th highest level, which caused considerable flooding from Lyndon to St. Johnsbury along Routes 5, 114 and 122.

The Winooski River at Essex Junction peaked at 16.28 feet (Flood Stage is being revised down to 12.0 feet) which flooded many roads, fields and farm land from Richmond to Lake Champlain. Additional flooding occurred along other smaller rivers.

May 20th Flash Flooding

On May 14th -16th, two to three inches of rainfall occurred across much of Vermont. This rainfall created very wet antecedent conditions, that was a primer for any possible flooding with additional rainfall.

On May 20th, narrow bands of showers and localized thunderstorms with very heavy rainfall moved southeast to northwest across portions of central and northwest Vermont.

Localized rainfall amounts in excess of 2 inches within 3 hours caused flash flooding in portions of Washington, Addison, Franklin and Windham counties, including Waitsfield amongst the hardest impacted.

May 26th-27th Severe Storms, Flash Flooding and River Flooding

During the afternoon and evening of May 26th, a series of severe thunderstorms and possibly a tornado or two (NWS surveys will be conducted May 27th and May 28th) moved across much of central and northern Vermont. There were several reports of damaging winds, numerous reports of large hail ranging from quarter (1 inch diameter) to greater than golf ball size (> 1.75 inches diameter) with reports of damage to siding, lawn furniture and vehicles. These reports were concentrated in Addison, Caledonia, Chittenden, Essex, Lamoille, Orange, Orleans and Washington counties.

In addition to the severe weather aspect of these storms, torrential rains accompanied these storms with rainfall rates of 1-2 inches per hour, including more than 3 inches in a three hour period in Montpelier and St. Johnsbury. During the late evening and overnight hours, numerous thunderstorms continued to "train" across central Vermont from Granville/Warren northeast across the Route 2 corridor from Middlesex/Montpelier through Plainville, Cabot, Danville, St. Johnsbury to Lunenburg in Essex county. (Figures 7,8)

Severe flash flooding occurred in many of these communities and led to very significant rises in two watersheds (Winooski and Passumpsic). The magnitude of this flooding was large in part to an abnormally wet spring, more than 200 percent above normal (Figure 1).

The Winooski River at Montpelier increased from near 5 feet at 7 pm EDT to 10 feet at 11 pm, exceeding flood stage of 15 feet at 1245 am EDT before cresting at 17.6 feet at 5 am EDT. The Passumpsic River at Passumpsic rose from 7 feet at 1230 am EDT to surpassing flood stage of 14 feet at 230 am EDT before cresting around 19 feet at 530 am EDT. (Figures 9, 10)

The Winooski River at Montpelier witnessed its first crest above flood stage since the Montpelier Ice Jam in March 1992 and its first crest above flood stage due to rainfall since June 30, 1973. The 17.6 feet crest is the highest ever recorded and 2nd all-time to the estimated 27.1 feet from the 1927 Flood. The Passumpic River at Passumpsic crest of 18.95 feet was the 4th highest recorded crest.

RECORD Lake Champlain Flooding

NWS Flood Stages for the United States Geological Survey (USGS) gages on Lake Champlain at the ECHO Center in Burlington, VT and Rouses Point, NY are 100.0 feet and were surpassed on April 13th. Major flooding can be expected for lake levels at or above 101.5 feet, which have been surpassed since April 27th (Figure 4)

When lake levels approach and/or exceed flood stage, wind direction and magnitude play an important role in potentially exacerbating flooding, by "piling water" on windward shorelines, called a seiche and large, damaging wave action.

Wind direction - South to southeast winds create seiches on south-southeast facing shorelines of New York and Vermont in central and northern Lake Champlain, while west to northwest winds greatly affect Vermont shorelines.

Wind magnitude - Brisk to strong (20 to 30+ mph) south-southeast winds can cause a seiche of several inches to over a half foot on the north end of Lake Champlain and south-facing shores as well as create waves of 2 to 4 feet above these higher levels. Likewise, north-northwest winds can cause seiche and damaging waves to southern Lake Champlain shorelines.

April 23rd, a strong south wind of 30 to 40 mph with gusts approaching 50 mph blew across Lake Champlain for nearly 12 hours and caused a significant seiche as well as battering and damaging 3 to 6 foot waves on south-facing shorelines. The initial lake level at Burlington was 101.0 feet, but briefly lowered to 100.7 feet, while at Rouses Point the initial level of 100.8 feet surged above 101.5 feet.

April 26th-27th, a very heavy rainfall event (1.5-3+ inches - Figure 3) along with continued snow melt within the Lake Champlain drainage basin (Figure 5,6) caused considerable river flooding. This attributed to lake levels that rose above major flood of 101.5 feet on April 27th and <u>surpassed prior historical records</u> while climbing to 102.5 feet on April 29th (Figures 2,4).

May 2nd, brisk south winds of 25 to 35 mph produced 3 to 4 foot waves that battered south-facing shorelines with already record normalized lake levels around 102.7 feet at Burlington and Rouses Point.

May 3rd-4th, another heavy rainfall event (1-2+ inches) occurred primarily in the northern Lake Champlain drainage basin. Prior to the onset of heavy rainfall, lake levels had receded to 102.6 feet, but then resumed rising to unprecedented levels reaching 103.0 feet on May 5th and cresting at 103.2 feet on May 6th. These flood levels greatly affected transportation between Grand Isle county and New York with the rest of Vermont.

May 9th and 10th, brisk north winds of 20 to 30 mph caused a pretty significant seiche on the southern end of Lake Champlain. The USGS gage at Whitehall, NY started at 102.9 feet but rose to 103.6 feet during the afternoon.

An 8-day (May 6-13th) reprieve with no precipitation across the Champlain Valley allowed for lake levels within Lake Champlain to recede from a record 103.2 feet on May 6th to 102 feet on May 15th.

However, a three-day rainfall event May $14^{th} - 16^{th}$ deposited 2 to 3 inches of rain across the Lake Champlain drainage basin. This rainfall forced the reversal in lake level recessions beginning on May 15th and eventually led the lake level to crest at 102.8 feet on May 20^{th} .

May 22nd- 23rd, a prolonged brisk to strong south wind of 20 to 30 mph, peaking to 40 mph on the 23rd, created 3 to 5 foot waves and an half foot seiche along south-facing shorelines, especially the northern end of Lake Champlain. The initial lake level at Rouses Point prior to the seiche was 102.55 feet but climbed to 102.9 feet at its peak during the afternoon of May 23rd. Lakeshore flooding was equivalent or exceeded the wind-driven episodes of April 23rd and May 2nd.

I have determined that the damage in certain areas of the State of Vermont resulting from severe storms and flooding during the period of April 23 to May 9, 2011, is of sufficient severity and magnitude to warrant a major disaster declaration under the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5121 *et seq.* (the "Stafford Act"). Therefore, I declare that such a major disaster exists in the State of Vermont.

In order to provide Federal assistance, you are hereby authorized to allocate from funds available for these purposes such amounts as you find necessary for Federal disaster assistance and administrative expenses.

You are authorized to provide Individual Assistance and Public Assistance in the designated areas and Hazard Mitigation throughout the State. Direct Federal assistance is authorized. Consistent with the requirement that Federal assistance is supplemental, any Federal funds provided under the Stafford Act for Public Assistance, Hazard Mitigation, and Other Needs Assistance will be limited to 75 percent of the total eligible costs.

Further, you are authorized to make changes to this declaration for the approved assistance to the extent allowable under the Stafford Act.

Under the provisions of Section 401 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. §§ 5121-5208 (the Stafford Act) I respectfully request that FEMA-4001-DR be amended to also designate Essex, Orange, and Washington Counties for Public Assistance and Hazard Mitigation. This request is based upon the recent joint Federal and State Preliminary Damage Assessments (PDAs) completed on July 15, 2011. The estimated per capita for Essex (\$49:24), Orange (\$32.25), and Washington (\$16.76) counties exceeds the required \$3.27 per capita needed to meet the federal declaration requirements. I have declared a major disaster under the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5121 *et seq.* (the "Stafford Act"), for the State of Vermont due to damage resulting from severe storms and flooding during the period of May 26-27, 2011. I have authorized Federal relief and recovery assistance in the affected area.

Individual Assistance, Public Assistance, and Hazard Mitigation will be provided.
