## I. The Vermont Bar Foundation is a charitable foundation sponsored by the Vermont Bar Association.

II. Funding source: The Foundation's revenue is the interest from attorney's IOLTA or "Interest on Lawyers' Trust Accounts." This is a program mandated by the Vermont Supreme Court. It requires lawyers or law firms to establish pooled interest-bearing accounts for client deposits which are nominal in amount or expected to be short-term. The interest generated by these accounts is then passed onto the Foundation. The Foundation distributes these funds in a grants process to programs who provide legal services to the disadvantaged and for educational programs relating to the courts and legal matters.

The Vermont Bar Foundation's by-laws state the purpose of the Foundation thus:

#### ARTICLE III. Purposes

The objects for which the Foundation is established are:

(a) To advance the science of jurisprudence and improve the administration of justice; to seek uniformity in judicial decisions; to contribute to schools, foundations and colleges and their departments engaged in the teaching and study of law, and their law libraries and law scholarship funds; to support legal aid facilities for the indigent and legal services corporations established under the provisions of Title 11 V.S.A., Chapter 19; to expend funds to provide for the defense of persons accused of unpopular crimes, acts or beliefs who are financially unable to employ counsel or defray the cost of proper defense; to contribute to public law libraries; to contribute to public programs providing for the physical improvement of courts and other agencies engaged in the administration of justice.

III. The languages we will translate our materials into are: French, Russian, Chinese, Vietnamese, Bosnian, and Swahili/Somali. (Somali is not commonly "known" as a written language, but rather a spoken language, but many people who speak Somali can read in Swahili.) These are the non-English languages currently most frequently spoken and written in Burlington, where the Parallel Justice Project is located.

The Center for Crime Victim Services applied for and received a grant from the Vermont Bar Foundation's Iolta Fund in support of the Parallel Justice Pilot Project in the City of Burlington. This Grant is for \$5,100 and will support a public outreach and education campaign to disseminate information to the general public, and to underserved crime victims in particular, about the new services that are available to them. A copy of the grant award letter and the AA-1 form are attached. This is a one-time grant and there is no financial impact on the Center or the state.

The Parallel Justice Pilot project was created to help better serve crime victims. During its first year the project hired two Parallel Justice specialists, one at the Burlington Police Department and one at the Community Justice Center, encouraged local businesses to donate goods and services, and established a Parallel Justice Commission. Lastly, the project launched a media campaign. This grant will be used solely in support of the education and media campaign. The goal of the campaign is to reach out to underserved victims of crime who do not qualify for Victims Compensation or other established programs with information about the Parallel Justice Project. Materials are being translated into six languages with the help of the Vermont Refugee Resettlement Program and the Association of Africans Living in Vermont.

### Vermont Bar Foundation

#### GRANT AGREEMENT

This Grant Agreement (the "Agreement") is made this day by and between the Vermont Bar Foundation ("Foundation") and Vermont Center for Crime Victim Services ("Grantee") to fund the Parallel Justice (the "Grant") in the amount of \$5,100 (the "Grant Funds").

The grant period covered by this Agreement is from July 1, 2007 to June 30, 2008.

#### I. INTRODUCTION

The provisions of this Agreement are applicable to and binding upon Grantee. The Grantee understands that the acceptance of the Grant creates a legal duty on the part of the Grantee to use the Grant Funds in accordance with the terms of this Agreement and to comply with all provisions and conditions of this Agreement.

It is understood and agreed by the Grantee that:

- A. Grantee will use the Grant Funds awarded solely and specifically for the purposes specified in its application and approved by the Vermont Bar Foundation. In the event Grantee cannot or does not use the funds in accordance with the approved use, all subsequent disbursements will be denied and Grantee agrees to return any funds improperly used.
- B. Grantee will immediately report to the Foundation any significant changes in the project funded by the Grant. "Significant changes" include, but are not limited to, the fact that the project cannot, for any reason, be undertaken or accomplished, or undertaken or accomplished at the time stated in the grant application.

#### II. GRANT CONDITIONS

The Grantee agrees to administer the Grant in compliance with the following terms and conditions:

- A. With the understanding and agreement that the Foundation, at its sole discretion, may grant funds in greater or lesser amounts and/or for greater or lesser periods of time than requested by the Grantee in its application.
- B. With the understanding that before the disbursement of the Grant Funds, the Foundation has the right to impose further conditions in the form of an addendum to this Agreement.



- C. With the understanding and agreement that, in the unlikely event that funds supporting this Agreement become unavailable or are reduced, the Foundation may terminate or amend this Agreement and shall not be obligated to pay any amounts awarded but not disbursed.
- D. With the understanding and agreement that the Grantee will deliver services in a non-discriminatory manner and without regard to race, sex, age, ethnicity, religion, sexual preference, gender identity or national origin.

#### III. GRANT ACCOUNTING AND RECORDS

- A. The Grantee will maintain records and accounts consistent with generally accepted accounting principles for organizations of its type, and provide for such physical control as is necessary to assure proper disbursing of an accounting for Grant Funds.
- B. The Grantee certifies that accounts and supporting documentation relating to Grant expenditures will be adequate to permit an accurate and expeditious audit by the Foundation or by its designated representative.

#### IV. GRANT REPORTS

- A. The Grantee will provide an interim status report no later than **January 30, 2008** which shall include the following information:
  - 1. A summary of receipts and disbursements of all VBF Grant Funds incurred during the reporting period.
  - 2. A narrative account of the Grant status, including a summary of the Grant goals articulated in its application versus accomplishments.
- B. The Grantee will provide a final report to the Foundation no later than August 31, 2008. The final report must include:
  - 1. A final financial report summarizing the use of the VBF Grant Funds, including a complete statement of income and expenses.
  - 2. A report of any Grant Funds surplus, including a refund of any unexpended Grant Funds remaining at the completion of the Grant. Refunds should be made by check payable to the "Vermont Bar Foundation."
  - 3. A final narrative report providing a detailed description of the Grant goals and its actual accomplishments.
  - 4. A copy of all audio/visual, literary products or publications resulting from the Grant.

- 5. Two or three brief summary descriptions, or vignettes, of how Grantee was able to assist individuals or educate Vermonters in the grant reporting year. Information to be used for publicity purposes by the Grantor. Grantee need not provide personal identifying information of those assisted by Grantee.
- 6. For Grantees who provide direct assistance to clients (e.g., representation, advice, support for pro se representation, lay advocacy) report the following information about individuals served using grant funds.:
  - \* List by county the number of individuals served
  - \* If grant funds provide partial support for larger efforts to provide direct client services, the percentage of clients served with grant funds.
  - \* Types of cases or legal issues
  - \* Outcomes of assistance
  - \* Demographics of individuals served, to extent that you already collect this information:
    - Age
    - ► Ethnicity
    - ▶ Gender
    - ► Race
    - Income

#### V. ACKNOWLEDGMENT OF SUPPORT

- A. All informational brochures, printed programs, publications, public reports and publicity releases printed with funding from the Foundation must acknowledge support of the **Vermont Bar Foundation**.
- B. The following disclaimer must be included in all informational brochures, printed programs, publications, public reports, films, audio and video recordings produced under the Grant, or announced at any public program concerning the Grant or its resultant product:

"The views expressed herein do not necessarily represent those of the Vermont Bar Foundation."

#### VI. LIABILITY

In making this Grant, the Foundation does not assume any liability or responsibility for the actions of the Grantee in carrying out the purposes of the Grant. By accepting Grant funds, the Grantee agrees to indemnify and hold harmless the Foundation from any and all claims of causes of action which are asserted against the Foundation as a result of the Grant.

<sup>&</sup>lt;sup>1</sup>This information will be compiled with demographic information from other VBF grantees to illustrate the extent to which VBF grants promote access to justice to a diverse population. Information from individual grantees will not be shared with any other agency or organization.

#### VII. NONCOMPLIANCE AND TERMINATION

Failure of the Grantee to comply promptly with any and all provisions of this Agreement shall be sufficient cause for the Foundation to terminate this Agreement. Such termination shall be effective on receipt by the Grantee of written notice from the Foundation. In the event of termination, the Grantee must still comply with the reporting, refund and reimbursement portions of this Agreement.

#### VIII. SPECIAL CONDITIONS

Notwithstanding any other provision of this Agreement, the Grantee accepts the following conditions:

Grant Funds will be used for the printing of translations of informational brochure, printing of posters, design and printing of volunteer brochures and print media.

#### IX. ACCEPTANCE

By execution hereof, Grantee hereby signifies its acceptance of the Grant Funds in the amount of \$5,100 from the Foundation under the terms and conditions stated in this Agreement, and hereby acknowledges that the undersigned is authorized to execute this Agreement on behalf of the Grantee and to bind the Grantee to the terms of this Agreement.

#### X. CONTROLLING LAW & JURISDICTION

This Agreement is governed by Vermont State Law. The exclusive jurisdiction for any litigation arising from this Agreement shall be Vermont State Courts. In the event of any such litigation, the prevailing party shall be entitled to reasonable attorney's fees.
