Subject: Grant Request #2861- #2867

Enclosed please find seven (7) items that the Joint Fiscal Office has received from the administration.

JFO #2861 – \$170,000 grant from the Federal Transit Administration to the Agency of Transportation. The funds will be used to establish a training program for Community Health Center staff so that they may act as mobility managers to help transportation-challenged individuals schedule and attend medical appointments. Approximately \$42,500 in State matching funds would be required, which are included in the Agency's FY17 budget. [JFO received 11/28/16]

JFO #2862 – \$480,000 grant from Federal Transit Administration to the Agency of Transportation. The grant will be used by the Agency to develop a statewide trip planner to include flexible or demand-driven routes, as well as hail-a-ride and other non-fixed route services, which would be incorporated into mobility applications. Approximately \$120,000 in State matching funds would be required, which are included in the Agency's FY17 budget.

**JFO** #2863 – \$13,000 grant from Vermont Birth to Five to the Agency of Education. The funds will be used to hire temporary staff to process license applications for early childhood educators to meet full-licensing requirements under Act 166. The Agency has experienced an unexpectedly high level of Pre-K applicants and the additional staff would help reduce the backlog and meet Act 166 deadlines.

**JFO** #2864 – \$30,000 grant from the Trust for Public Land to the Vermont Dept. of Forests, Parks and Recreation. The funds would be used to pay for stewardship planning and improvements to the 2,085 acres that were recently acquired to expand Camel's Hump State Park. The funded activities would include trailhead parking, replacing culverts, developing signage, improving roads and trails, performing natural resource inventories and public involvement events.

**JFO** #2865 – \$15,000 grant from the Vermont Ski Areas Association to the Agency of Agriculture, Food and Markets. The funds serve as a donation to support the Working Lands Fund.

**JFO** #2866 – \$10,000 grant from Advocates for Youth to the Agency of Education. The funds would be used to pay for training materials and technical assistance provided to Vermont teachers for the improvement of sexual health education in the State.

**JFO** #2867 – \$100,000 grant from Vermont Technical College (VTC) (as a sub-grant of federal funds) to the Department of Economic Development. The funds will be used to pay for existing staff within the Department to dedicate time to working with employers to identify needed skills in order to create pathways to employment. This sub-grant is part of a \$4 million grant received by VTC from the U.S. Department of Labor under a project titled the *Strengthening Workforce Families Initiative*. The awarded funds will be allocated to the Department in \$25k increments from State FY 2017 through FY 2020.

## State of Vermont Request for Grant Acceptance (Form AA-1) Project Narrative: Supplemental Funding for Licensing related to PreK

### Description of Project Deliverables

The Agency of Education (AOE) will utilize the funds to purchase additional temporary staff time to process licenses for the high influx of early childhood educators seeking peer review and transcript review to become fully licensed to meet Act 166 requirements.

### **Need for Project**

Act 166 requires that public and private preK providers have a fully licensed teacher to in order to be prequalified to provide education services to students. Currently, the early childhood community has found a lack in the number of licensed educators available to meet this need. Through stakeholder engagement and project team meetings, multiple solutions were proposed for addressing this shortfall.

Among them was a recommendation that non-profit community groups would support private providers in pursing licensure through peer review as a way to obtain a license. This support has created an unanticipated uptick in peer review applications and given staff constraints, the wait time for clearance is longer than applicants would like.

As part of the joint stakeholder and Early Childhood committee work, Vermont Community Preschool Collaborative/Vermont Birth to 5 offered to support the hiring of temporary staff to assist the Agency in meeting the timelines associated with processing licenses. The current timelines cannot be met due to the increased volume of preK license applications exceeding the typical volume that current staffing can address.


To offset this short term work flow problem, Vermont Birth to Five is offering to fund temporary staff that will help the Agency to meet the deadlines associated with processing these preK licenses, increase applicant satisfaction and support achieving the goals of Act 166.

### **Project Objectives**

By the end of the term of agreement for this grant (June 30, 2017), we expect that:

1. The AOE will process 90% of preK peer review licenses within 90 days of portfolio submission.
