JFO #3122 – One (1) limited-service position, Financial Administrator III, to the Vermont Agency of Natural Resources, Central Office. Provide a brief justification/explanation of this request: This position is needed within the Agency of Natural Resources Central Office to help with the sharp increase in the amount of accounts payable and accounts receivable transactions coming from DEC as a result of the \$40~ million of ARPA funding related to water / wastewater solutions, grants, contracts, technical assistance, and needs assessment services for underserved / under-represented Vermonters (i.e., manufactured housing community (mobile home park) residents and low income Vermont homeowners) as well as increased activity of the same for the ARPA funded 3 acrestormwater program. This increase in funding came into the DEC's FY23 Budget under the Healthy Homes Approp - Act 185 (G.700(a)(4)(B)(i/ii) and G.700(a)(6)(B) and the 3 acre stormwater funding under Act 185 - G700(A)(1)(a).
