No Joint Fiscal Committee member has requested that the following items be held for review:

JFO #2270 – Donation of a boat, trailer and motor from the U.S. Department of Agriculture, Wildlife Services to the Department of Fish and Wildlife. These items will be used by the Department and have a combined inventory value of \$10,820. [JFO received 09/19/06]

JFO #2271 – Donation of a 4.51 acre parcel from the Hinesburg Land Trust to the Department of Fish and Wildlife. This parcel of land (valued at \$53,274) is located in Hinesburg. This acreage will be added to the Lewis Creek stream bank parcels previously purchased from Marion Welch and donated by the Hinesburg Land Trust.

Re: Joint Fiscal Request – Welch Acquisition by Department of Fish and Wildlife

Tom Decker, Department of Fish and Wildlife, asked me to provide information to you regarding the LARC (Land Acquisition Review Committee) process in general and specific information regarding the proposed acquisition of 4.5 acres from the Hinesburg Land Trust in the Town of Hinesburg referred to as the Welch parcel. Below is a summary that will hopefully answer your questions. I also have sent information to you via mail that directly relates to LARC's review of this proposed acquisition. Please feel free to contact me if you need additional information.

The ANR Land Acquisition Review Committee currently consists of 8 members from two agencies. The Agency of Natural Resources is represented by 2 members from each of the three Agency Departments, F&W, FPR and DEC. In past years a representative from the Agency Secretary's staff has participated, in which case 9 committee members were active, but that position has remained vacant since Secretary Torti was appointed. The Agency of Transportation is also represented by 2 members. Projects are presented to LARC from a variety of sources including ANR staff, landowners and various nonprofit conservation organizations. In the case of this 4.5 acre parcel, the Hinesburg Land Trust was the sponsoring organization. They provided LARC with a written explanation of the proposal and maps of the parcel to be conveyed to Fish and Wildlife. As with all acquisition proposals being considered by LARC, this information is forwarded to field staff from Forests, Parks and Recreation and Fish and Wildlife for comment and recommendations to assist LARC. Recommendations from the field staff and guidance provided by the Agency's Lands Conservation Plan, adopted in October, 1999, are used to help LARC review proposals. Once LARC makes a recommendation regarding an acquisition it is forwarded to the Agency Secretary via the Commissioners for each of the three Agency Departments for a final decision. Typically, the Secretary concurs with LARCs' recommendations but not always.

In the case of the Welch property, Mike Snyder, County Forester, and Bill Crenshaw, Wildlife Biologist, were familiar with the property and provided input to LARC. Bill Crenshaw is also a member of LARC so he was able to contribute verbally to the discussion regarding this acquisition during the meeting on 9/16/2005. LARC's recommendation to acquire this 4.5 acre parcel was made because the parcel was adjacent

to land already owned by Fish and Wildlife, Lewis Creek Streambank, it was a high priority for the Hinesburg Land Trust and had good local support and, although small, it is a reasonably nice woodlot that added value to the adjoining state owned property. This acquisition was not considered a high priority but given that it was a donation and enhanced existing state land, it was recommended for acquisition contingent upon a site visit by ANR staff, marking the perimeter of the property and acceptable easement language. The Hinesburg Land Trust has taken responsibility for completing pre-closing tasks, such as drafting the deed, title search, survey etc. Secretary Torti approved the recommendation on 11/14/05. The surrounding state owned property is encumbered with a conservation easement which will be amended to include this 4.5 acre parcel with no easement language changes. Having consistent easement language on all the Lewis Creek Steambank parcels makes management of the property easier.

We do not as a matter of routine have an environmental assessment completed on property we purchase. Field staff visit potential acquisitions and look for evidence of hazardous materials which can sometimes lead to have an evaluation but typically they are not done. In the case of the Welch property, Andrea Morgante from the Hinesburg Land Trust has walked the entire property and did not find anything that would raise concerns.






