Enclosed please find one (1) item, which the Joint Fiscal Office has received from the Administration.

JFO #3112 – Land donation from The Nature Conservancy, Montpelier, VT to the Vermont Agency of Natural Resources, Department of Fish and Wildlife. 80 acres of land in the Town of Brandon, VT, with an assessed value of \$68,500, to be added to the Brandon Swamp Wildlife Management Area. These 80 acres are a portion of a larger 421-acre donation by 6 different landowners over several towns. The Department of Fish and Wildlife expects to expend \$400 for closing costs and confirms the funds are available in their budget. [Note: This request is to accept 80 acres only though the packet contains some information on the full 421-acre donation.]

Management Area (WMA) located in the Town of Brandon, totaling 421 acres.

Enclosed is an approval to be signed by Governor Scott for the acquisition of 10 parcels of land from 6 owners totaling 421 acres in Brandon and Sudbury. These properties are located along Otter Creek, and one parcel surrounds an existing State-owned river access. This land will be added to Brandon Swamp WMA and will advance the Vermont Fish and Wildlife Department's goal of conserving wetland habitats in the Lake Champlain watershed and increasing public access to the outdoors. Total costs for this project are approximately \$48,200 for acquisition, survey, and legal fees.

Funding for this acquisition will come from the Department's Duck Stamp funds. Included with the Governor's approval memo are maps of the properties and a copy of the town support. <u>Recommendation:</u> Approve the acquisition of 421 acres by the Vermont Fish and Wildlife Department to conserve significant wetland habitat and improve public access to the WMA.

Description

The 278 acre Brandon Swamp WMA is located in the northwest corner of the town of Brandon, and extends northward into the town of Leicester. It is one of seven named swamps that make up the 15,500 acre Otter Creek Swamps wetland complex, stretching from Brandon to Middlebury. It is considered the most biologically diverse swamp complex in New England. According to the Vermont Fish and Wildlife Department's (VFWD's) description of the Brandon Swamp WMA, it is a "large floodplain swamp with cedar ringed by red maple-black ash hardwoods...the red maple-northern white cedar swamp is mossy and hummocky, with hidden pools. In the riparian areas, there are silver maple, willow, elm, basswood and cottonwood. It occupies approximately 1.5 miles of the western streambank of Otter Creek." Other habitats and natural communities identified in the swamp include red maple-black ash seepage swamp, maple-green ash swamp, and two types of floodplain forest, silver maple sensitive fern and silver maple ostrich fern floodplain forest. This system of wetlands provides important habitat for waterfowl, wading birds, songbirds, raptors, deer, turkey, beaver, otter, muskrat and many other wetland-dependent wildlife. It also supports outstanding hunting, fishing, trapping, and wildlife watching opportunities that are cherished by many residents and non-residents of Vermont.

In the early 2000s, a concerted effort by the U.S.D.A., Natural Resources Conservation Service's Wetland Reserve Program (WRP), now known as the Wetland Reserve Easement Program (WRE) resulted in the permanent conservation and hydrological restoration of much of the land, mostly clustered immediately north and south of VT Route 73. All of the parcels listed for acquisition in this proposal are currently encumbered with WRE easements except for the Hathaway property. While much of the ecological functions of this land are already protected through these easements, the land can still be posted, and in this area there has been a trend of land being acquired for use as private hunting grounds. Therefore, the primary objective of these acquisitions is to improve public access while establishing a corridor of public lands along the Otter Creek to benefit fish, wildlife and water quality.

Being enrolled in WRE, the cost of management of the properties are borne by NRCS. All of the properties except Stone are "swamp lots", floodplain forest with not road access. Motor vehicles are not allowed, nor will they be under FWD ownership. There are no existing trails and public access is currently prohibited.

The FWD's 2017 strategic plan for land acquisition named Brandon Swamp as a locus for additions to the WMA, "with a vision to connect Brandon Swamp to Cornwall Swamp". The plan specifically mentions the opportunity for acquisition of the WRP/WRE and town-owned parcels. The VFWD focus on wetland conservation along this portion of Otter Creek pre-dates our more recent EPA funded wetland conservation work and, in fact, is a useful complement to our expanded wetland conservation efforts. This has led to a recent joint effort with The Nature Conservancy, and in support of this, TNC has agreed to transfer their 80-acre ownership to the WMA as a donation. The other donated parcels include: Hathaway (10 acres), and McKirryher (two 9-acre parcels). The parcels to be purchased in fee simple include: Bertrand (3 parcels of 45, 33, and 32 acres), Ketcham (32 acres), and Stone (2 parcels of 116 and 54 acres). See attached map. The addition of these lands to Brandon Swamp WMA will provide permanent public access to areas that provide unique opportunities for waterfowl hunting, turkey hunting, upland bird hunting, deer hunting, fishing, canoeing, bird watching and more. Access will be associated with Route 73, a primary state road and with the Otter Creek Access Area in Sudbury, which the Ketcham parcel abuts. The Access Area thus provides parking and other amenities to this project. This project will also ensure long-term stewardship of these wetlands by the VFWD. Duck Stamp funds will pay for purchases and associated costs for all lots, including legal fees, with an estimated cost of approximately \$48,200.

The total tax assessed value of all lots to be acquired is \$170,005. The estimated PILOT payment will be approximately \$1,600. PILOT payments will be funded by state clean water funds. The parcels, being enrolled in WRE, will be largely managed by NRCS. Any management costs that arise for the Department will be funded with Pittman-Robertson funds. The continued management of the WMA and these parcels will focus on habitat and public access.

Approval by the Governor of Vermont for this acquisition of property is required by 10 V.S.A. §4144, that states in part, "[T]he Secretary, with approval of the Governor, may acquire for the use of the Department of Fish and Wildlife by gift, purchase, or lease any and all rights and interests in lands, ponds, or streams, and hunting and fishing rights and privileges in any lands or waters in the State, and the necessary rights of ingress or egress to and from such lands and waters. The Secretary's authority to acquire property interests under this section shall include all of the interests that may be acquired under subsection 6303(a) of this title."

In addition, the towns of Brandon and Sudbury support this project as approved at their April 26 and May 3, 2021, respectively, Select Board Meetings. A copy of the Brandon meeting minutes and a letter of support from Sudbury are attached herein.

APPROVAL FOR PURCHASE OF LANDS

We the undersigned, hereby approve the acquisition of 421 acres in Brandon and Sudbury, Vermont by the Vermont Agency of Natural Resources, Fish and Wildlife Department to improve and protect public access, restore wetlands, improve water quality, and conserve fish and wildlife habitat. This approval is required by 10 V.S.A. §4144 of the Vermont Statutes Annotated.





Background and Purpose of the Acquisition: The 278 acre Brandon Swamp WMA is located in the northwest corner of the town of Brandon, and extends northward into the town of Leicester. While much of the ecological functions of this land are already protected through these easements, the land can still be posted, and in this area there has been a trend of selling the land to use as private hunting grounds. Therefore, the primary objective of these acquisitions is to improve public access while establishing a corridor of public lands along the Otter Creek.

The FWD's 2017 strategic plan for land acquisition named Brandon Swamp as a locus for additions to the WMA, "with a vision to connect Brandon Swamp to Cornwall Swamp". The plan specifically mentions the opportunity for acquisition of the WRP/WRE and town-owned parcels. The VFWD focus on wetland conservation along this portion of Otter Creek pre-dates our more recent EPA funded wetland conservation work and, in fact, is a useful complement to our expanded wetland conservation efforts. This has led to a recent joint effort with The Nature Conservancy, and in support of this, TNC has agreed to transfer their 80-acre ownership to the WMA as a donation. The other donated parcels include: Hathaway (10 acres), and McKirryher (two 9-acre parcels). The parcels to be purchased include: Bertrand (3 parcels of 45, 33, and 32 acres), Ketcham (32 acres), and Stone (2 parcels of 116 and 54 acres). See attached map. The addition of these lands to Brandon Swamp WMA will provide permanent public access to areas that provide unique opportunities for waterfowl hunting, turkey hunting, upland bird hunting, deer hunting, fishing, canoeing, bird watching and more. Access will be associated with Route 73, a primary state road. An added benefit to this project is an existing VFWD fishing and boat launch access adjacent to the Ketcham property, thus providing parking and other amenities to this project. This project will also ensure long-term stewardship of these restored wetlands by the VFWD. Duck Stamp funds will pay for purchases and associated costs for all lots, including legal fees, with an estimated cost of approximately \$48,200.

APPROVAL FOR DEVELOPMENT OF A CONSERVATION PROJECT: I hereby approve the development of a land acquisition project consisting of ten parcels located in Brandon and Sudbury, Vermont. This approval authorizes the VFWD to pursue the development of this project and does not supersede other requirements, statutory, regulatory, procedural or policy, for the State of Vermont to accept interest in real property (e.g., Governor Approval).

PLEDGE OF LAND

On this 21 57 day of April, 2021, The Nature Conservancy (the "Conservancy"), pledges to donate to the State of Vermont, Department of Fish and Wildlife, its successors and assigns, in fee simple, the following described land (the "Parcel"), with any buildings and improvements thereon, if any, and any rights, hereditaments, easements and appurtenances thereunto belonging, located in the Town of Brandon, County of Rutland, State of Vermont, containing 80 acres, more or less, and more particularly described in Exhibit A attached hereto and made a part hereof. The Conservancy agrees to donate the Parcel to the State of Vermont on or before December 31, 2022.

TERMS AND CONDITIONS OF PLEDGE

- 1. At the time of transfer, the Conservancy will execute and deliver to the State of Vermont a good and sufficient Warranty Deed conveying a good, insurable and marketable title to the Parcel, and all mineral rights, with the hereditaments and appurtenances thereunto belonging, in fee simple, free and clear of all liens, encumbrances, or exceptions, except such easements, restrictions and other exceptions of record as will not adversely affect the State of Vermont's intended use of the Parcel as an addition to the Brandon Swamp Wildlife Management Area.
- 2. All taxes, assessments, and encumbrances which are a lien against the land at the time of conveyance to the State of Vermont shall be satisfied of record by the Conservancy at or before the transfer of title. The Conservancy shall pay the documentary revenue stamp tax or transfer, conveyance or recordation tax, assessment or charge, if any.
- 3. The Conservancy agrees not to make any alterations or improvements to the Parcel prior to transfer to the State of Vermont. In the event of such actions the State of Vermont may, without liability, refuse to accept the conveyance of title.
- 4. All risk of loss or damage to the Parcel will pass from the Conservancy to the State of Vermont at closing.
- 5. The State of Vermont may enter upon the Parcel at reasonable times for surveying and other reasonable purposes related to this transaction. The State of Vermont shall have the right to conduct an environmental inspection and assessment of the Parcel, and based upon said inspection may, at its discretion, refuse to accept the conveyance of any interest in the Parcel at any time prior to closing.
- 6. This pledge and its terms and conditions are a binding obligation on the Conservancy and shall apply to and bind the successors and assigns of the Conservancy.
