Personnel

Domestic Violence Response Coordinator: This person will be at the rank of captain in the Vermont State Police and serve as the Director of Fair and Impartial Policing and Community Affairs. They will provide training and technical assistance to the Vermont State Police on updates to policies, protocols, and procedures during project implementation.

The budget provides for the Domestic Violence Response Coordinator for a total of up to 2 visits per year (up to 6 visits) to provide the intensive technical assistance and implementation to the Vermont State Police outlined in the project narrative.

Dear Commissioner Schirling:

Congratulations on your recent award. The Office for Civil Rights (OCR), Office of Justice Programs (OJP), U.S. Department of Justice (DOJ) has been delegated the responsibility for ensuring that recipients of federal financial assistance from the OJP, the Office of Community Oriented Policing Services (COPS), and the Office on Violence Against Women (OVW) are not engaged in discrimination prohibited by law. Several federal civil rights laws, such as Title VI of the Civil Rights Act of 1964 and Title IX of the Education Amendments of 1972, require recipients of federal financial assistance to give assurances that they will comply with those laws.
