SUBJECT: Donation of \$100,000 from Amber Jean Productions, Inc.

The Joint Fiscal Committee has received a request from the Department of Finance and Management to approve the acceptance of a \$100,000 donation from Amber Jean Productions, Inc. for the "Food Fight Fund." This organization is based in Los Angeles, CA.

Section 4 of Act No. 120 of 2014 established the Genetically Engineered Food Labeling Special Fund to pay the costs or liabilities incurred by the Attorney General or the State in implementation and administration, including rulemaking, of the requirements, of the food labeling law. Deposits into the fund include private gifts, bequests, grants, or donations as well as \$1.5 million from settlement monies collected by the Attorney General's Office. To date the fund has received \$1.5 million from the settlement funds and \$651,000 from private donations, including this \$100,000, for a total of \$2,151,000.

Please review the enclosed materials and notify the Joint Fiscal Office (Maria Belliveau at (802) 828-5971; mbelliveau@leg.state.vt.us) if you have questions or would like this item held for legislative review. Unless you respond to the contrary by October 7, 2015 it will be assumed that you agree to consider as final the Governor's acceptance of this donation.
