Enclosed please find two (2) items that the Joint Fiscal Office has received from the administration.

JFO #2690 – \$15,000 grant from the National Alcohol Beverage Control Association to the Vermont Department of Liquor Control (DLC). These funds cover costs associated with an educational event designed to improve understanding of alcohol regulations, current DLC operations, and privatization risks. The event will bring together policy makers, licensees, law enforcement professionals, and others. [JFO received 07/11/14]

JFO #2691 – \$10,250 grant from the Alma Gibbs Donchian Foundation to the Vermont Department of Housing and Community Development. These funds will be used by the Historic Preservation division for various improvements at the Hubbardton Battlefield (\$4,500), to support two Grace Coolidge Musicale events in Plymouth (\$2,750) and to cover the cost of staffing at the Justin Morrill Homestead for three additional days per week during the 2014 season (\$3,000).

## 8. Purpose of Grant:

The donations are for: 1) \$4500 for new exhibit wayfinding signs (code 522400; \$3830) and speakers for the projector in the Visitor Center (code 522200, \$670) at Hubbardton Battlefield, 2) \$2750 for two Grace Coolidge Musical events at the Calvin Coolidge Historic Site (code 519000; \$1375 each), and 3) \$3000 to open Justin Morrill State Historic Site an additional 3 days per week to the public (code 500000 salaries; \$1000 daily).

### 9. Impact on existing program if grant is not Accepted:

The effects on the existing programs if the donations are not accepted would require a redirection of funds to keep the Justin Morrill State Historic Site open additional days as advertised. Overall, the redirection of funds would lessen our ability during the 2014 season to provide a few events and programs, affect marketing and outreach, and possibily require a reduction in seasonal staffing. Additionally, without these donated funds, aged and weathered waysigns at Hubbardton Battlefield could not be replaced and the Grace Coolidge Musicales at the President Calvin Coolidge State Historic Site would be canceled.

The Vermont Division for Historic Preservation (Division) and the Vermont State Historic Sites respectfully request approval to accept grants from the Alma Gibbs Donchian Foundation for the following undertakings:

1. \$4,500 for new wayfinding signs that recount the July 7, 1777 events between the American army and the British redcoats and to install speakers for the visitor center's projection system at Hubbardton Battlefield. The signs will be \$3830 and the speakers will be \$670;

2. \$2,750 for two Grace Coolidge Musicale events in Plymouth on June 29 and September 7; and

3. \$3,000 to pay the salaries to have the Justin Morrill Homestead in Strafford open to the public three additional days per week during the 2014 season. This will require only one staff person onsite, opening the property from Wednesday to Friday. Regular hours are Saturday and Sunday for the 2014 season.

The Alma Gibbs Donchian Foundation has been a devoted benefactor for many years, providing funding beyond their primary mission to support the activities and events at Vermont's state-owned historic sites. It has been a particular endeavor of the Foundation's board to establish a partnership with the Division to promote Vermont's heritage and history. The Division and the Historic Sites administrators welcome this collaboration in order to continue producing inspiring, thought-provoking experiences for visitors.

We are grateful to the Alma Gibbs Donchian Foundation for such extensive support this year in particular.
