Subject: Grant Request #2700, #2701, #2702, #2703

Enclosed please find four (4) items that the Joint Fiscal Office has received from the administration.

JFO #2700 – \$97,443 grant from the U.S. Department of Agriculture to the Vermont Agency of Agriculture, Food and Markets. These funds will be used to study the economic feasibility using gas from farm anaerobic digesters as fuel for farm equipment. [JFO received 09/05/14]

JFO #2701 – \$50,000 grant from Kent Whealy to the Vermont Department of Finance and Management. These funds will a portion of the cover costs associated with implementation and administration of new law that requires labeling of food produced from genetic engineering. The donated funds will be deposited in the Vermont Food Fight Fund. [JFO received 09/05/14]

JFO #2702 – \$5,000 grant from Stonyfield Farm, Inc. to the Vermont Department of Finance and Management. These funds will a portion of the cover costs associated with implementation and administration of new law that requires labeling of food produced from genetic engineering. The donated funds will be deposited in the Vermont Food Fight Fund. [*JFO received 09/05/14*]

JFO #2703 – \$1,000,000 grant from U.S. Department of Health and Human Services to the Vermont Department of Health. These funds will be used to increase access to health care services by increasing funding for load repayment programs designed to recruit and retain primary care, dental, and psychiatry providers. This grant requires a \$1,000,000 state match that was appropriated in the FY2015 budget bill. [*JFO received 09/05/14*]
