SUBJECT: JFO #2779 Donation of \$25,000 from SumOfUs for the "Food Fight Fund"

The Joint Fiscal Office has received a request for Joint Fiscal Committee approval of a \$25,000 donation from SumOfUs for the "Food Fight Fund." This organization is based in San Francisco.

Section 4 of Act No. 120 of 2014 established the Genetically Engineered Food Labeling Special Fund to pay the costs or liabilities incurred by the Attorney General or the State in implementation and administration, including rulemaking, of the requirements, of the food labeling law. Deposits into the fund include private gifts, bequests, grants, or donations as well as \$1.5 million from settlement monies collected by the Attorney General's Office. To date the fund has received \$1.5 million from the settlement funds and \$551,000 from private donations, including this \$25,000, for a total of \$2,051,000.
