Enclosed please find three (3) items that the Joint Fiscal Office has received from the administration. Five (5) limited service position requests are included in these items.

JFO #2574 – Request to establish **four limited service positions** in the Department of Labor. These positions will enhance the Department's ability to re-employ claimants by interviewing claimants and developing plans designed to obtain employment for claimants. Funding for these positions was approved during the FY13 budget process.

JFO #2575 – Request to establish one limited service position in the Department of Public Safety's Vermont Fusion Center. This position will provide crime analysis to investigators, and act as the Statewide Police Intelligence Network liaison at local and regional meetings. Funding for this position was approved in JFO 2108, a homeland security grant.

JFO #2576 – \$66,848 grant from the U.S. Department of Health and Human Services to the Vermont Department for Children and Families. These funds will support the guardianship assistance program that provides financial support for children, formerly in DCF custody, whose relatives have assumed guardianship duties.


Re: Proposal to Create Three New Crime Analyst Positions in Vermont Fusion Center




This memo proposes to establish the new crime analyst positions within the Vermont Fusion Center using dedicated Homeland Security Grants. These grants have been committed to sustain these positions for the next four years and further awards will continue them for the foreseeable future.

The Vermont Law Enforcement Community has recognized the critical importance of gathering and sharing of criminal information and its benefit to a successful criminal investigation. By statute, the Vermont State Police is responsible for criminal information sharing both within state and regionally through the Vermont statutes and the New England State Police Administrative Compact (Title 20 VSA 1811, 1814 and 1951). In 1977 the Vermont State Police established the Criminal Intelligence Unit and charged it with the responsibility for collecting, analyzing and sharing of critical information pertaining to crime to all law enforcement throughout the state and New England. This intelligence function progressed and in 2005 it established the Vermont Fusion Center. The VTFC combined the Criminal Intelligence Unit with other intelligence entities in state to establish a central point of contact for all LE activities. The VTFC provides vital services to the LE community. These responsibilities include major case support for lost or missing persons. By statue the Commissioner. delegated to the Vermont State Police VTFC, is responsible for the coordination of all missing persons within the state (Title 20 VSA 1827). The VTFC maintains vital records and a database for all missing persons for the purposes of assisting investigators in locating them. Additionally, the Commander of the VTFC is responsible for the state's Amber Alert program which compliments and enhances the investigation of missing persons (children) when there is an immediate danger to the child. The VTFC provides major case support for all LE Agencies throughout the state. This includes assisting in homicides, narcotics, sex crimes and other major investigations. Finally, the VTFC provides vital information to track crime trends and analysis.

As a result of the important work done by the staff at the VTFC, it has experienced a 374% increase in requests for services since 2005. Additionally, the VTFC has experienced an average 81% increase in requests each month. Finally the average request for services per month per analyst has increased from 29 to 99. Below are graphs illustrating these facts:




Yearly Total Requests from Law Enforcement Agencies in the State of Vermont January 2006 through May 13, 2011





One of the most important success stories of the VTFC has been its ability to engage other law enforcement agencies in information sharing. The VTFC staff work tirelessly to interact with local, county, state and the federal law enforcement agencies. From 1977 through 2005 the predominant users of the criminal intelligence services has been the Vermont State Police. In 2005 the increase in the types of users of the services the VTFC offered began to shift to local, county and federal law enforcement agencies. The graph below illustrates the percentage of increase by types of users for requests for services:



This increase has exposed several gaps that were recently noted during an assessment of the VTFC. During the fall of 2010 the VTFC was assessed in its ability to process criminal information. It was noted that the VTFC lacked the resources necessary to process all of the available information to produce a timely document to inform police commanders of crime trends and other analysis. This analysis of crime is extremely beneficial to police commanders as it allows them to decide where resources should be assigned to address problems.

While the VTFC has had a significant workload increase it has also lost two positions from other agencies that were assigned to the VTFC. This loss of personnel has significantly increased the number of requests for services each analyst now handles per month and is illustrated below:



As mentioned previously, the Vermont Law Enforcement Community has recognized the importance of the work that the VTFC offers. In FFY 2009 and 2010 the hiring of additional analyst at the VTFC was a major investment in these grant applications. The Homeland Security Working Group recommended that a portion of the grant support additional staffing in the VTFC. These Chiefs and Sheriffs recognized the benefit of a fully staffed center and its contributions to a successful investigation. However, we were not able to create these new positions due to the fiscal crisis the state faced during this time frame. Several other options were explored to fill these positions but we were unsuccessful. We now believe it would be appropriate to support the creation of three new state positions for the positions of criminal analyst. Recently we met with the local Law Enforcement Working Group to confirm their continued support for this idea of creating three new positions. The group has committed \$190,000 to establish three new positions in FFY 2010 HS Grant and has committed another \$615, 818 to sustain these three positions for an additional three years from FFY 2011 HS Grant Award.

- 1. Assist law enforcement agencies by providing specific analytical assistance in the areas of crime analysis, telephone toll analysis, link analysis, event analysis, and financial analysis for their investigations.
- 2. Prepare written and oral reports summarizing the results of analytical work, which will be reviewed by the supervisor of the unit and sent to the requesting agency.
- 3. Daily review of on-line services, incoming bulletins, newsletters, and journals in order to be aware of current trends regarding criminal activity and to identify patterns or similarities that would be of value to law enforcement agencies.
- 4.Review and maintain material on assigned topics of specialization such as White Supremacy Groups, Street Gangs, Outlaw Motorcycle Gangs and other various hate and criminal type organizations and be responsible for disseminating this information while assisting law enforcement agencies during investigations.
- 5. Perform as the Statewide Police Intelligence Network (SPIN) liaison at local and regional information sharing meetings as a representative for the Vermont Fusion Center and provide any relevant material, which may be appropriate for sharing with members through Law Enforcement Bulletin.
- 6. Conduct audits of the databases to ensure that all entries comply with Federal Regulations.
- 7. . Responsible for preparation and posting of specialized topics for topics such as safety messages, missing persons.
- 8. Assist in the training of members of law enforcement agencies as to the operation and functions of the Statewide Police Intelligence Network, the benefits of the analysis of information, and other topics related to information of crimes
