As you know, the American Recovery and Reinvestment Act of 2009 will provide substantial funding for Vermont. In the energy sector alone, Vermont will see over \$30 million for renewable energy and energy efficiency – a significant increase in funds, especially when viewed in the context that Vermont normally receives about \$5 million for clean energy from Entergy. These new ARRA funds, in addition to anticipated Entergy funds, will result in over \$50 million in the next two years which has been appropriated for Clean Energy Development (CED).

This letter is a formal request to expedite Joint Fiscal processes and approvals for the hiring of limited service employees for the department of public service. Both because of the demands imposed by the aggressive timelines for granting of these funds and the programmatic ramp up and because it is in the best interest of Vermont to create new green jobs as quickly as possible, the department requires immediate permission to create and fill temporary positions. As the legislature anticipated, new staffing is required to meet new demands and seize new opportunities. The more slowly we staff up, the slower the benefits and the more likely that Vermont will forfeit funds. Obviously we'd like to be positioned to receive funds other states forfeit.

These proposed CED positions will be fully funded through the ARRA State Energy Program. The department intends to employ two full time positions to start, and release a request for proposal for consulting services for a third, technical-level position. It is likely these positions will be required for the duration of the ARRA funding period – up to three years.

single project directly or indirectly receives a grant in more than one of these categories:

* * *

(9) The clean energy development board is authorized, to the extent allowable under ARRA, to utilize up to 10 percent <u>of</u> ARRA funds received for the purpose of administration. One half of this amount shall be allocated to the treasurer to retain permanent, temporary, or limited service positions or contractors to administer such funds, and the other half of this amount shall be allocated to the oversight of specific projects receiving ARRA funding through the clean energy development fund. The board shall allocate a portion of the amount utilized for administration to retain permanent, temporary, or limited service positions or contractors to administer such funds and the remaining portion to the oversight of specific projects receiving ARRA funding through the clean energy development fund.

(i) The treasurer shall consult with the other directors of the clean energy development fund board and the commissioner of public service and adopt rules pursuant to 3 V.S.A. chapter 25 to carry out this section. The treasurer shall adopt an initial set of rules under this subsection no later than July 15, 2009 and may use the emergency rulemaking process provided under 3 V.S.A. § 844 to do so. In adopting the initial set of rules, the treasurer shall consult with any at large board directors who have been appointed, the chief recovery
